1. ESTABLISHMENT OF AN AGENCY OR A DEPARTMENT OF THE UNITED NATIONS FOR UNDERTAKING, COORDINATING AND DISSEMINATING THE RESULTS OF RESEARCH INTO UNIDENTIFIED FLYING OBJECTS AND RELATED PHENOMENA (UNGA ITEM 126) IS SCHEDULED TO BE TAKEN UP BY THE SPECIAL POLITICAL COMMITTEE (SPC) ON 27 NOVEMBER. UNDAUNTED BY A LACK OF RESPONSE TO THE ITEM DURING AND SINCE THE 32ND UNGA, PRIME MINISTER GAIRY HAS APPARENTLY LAID THE GROUNDWORK FOR A BLITZKRIEG SALES PITCH WHICH WILL INCLUDE A CAST OF SUPPORTERS RANGING FROM SCIENTISTS TO ASTRONAUTS, SUPPLEMENTED BY A HOLLYWOOD FILM PRODUCTION.

2. MISSION HAS LEARNED THAT GRENADA'S MINISTER OF EDUCATION, DR. FRIDAY, WILL INTRODUCE A RESOLUTION (AS YET NOT DISTRIBUTED) TO THE SPC FOLLOWED BY TESTIMONY FROM FOUR OR FIVE EXPERTS POSSIBLY INCLUDING: DR. J. ALLEN HYNEK (U.S. ASTRONOMER), DR. JACQUES VALLEE (FRENCH ASTRONOMER), DR. CLAUDE POHER (FRENCH UFO STUDY GROUP), DR. DAVID SAUNDERS (PSYCHOLOGIST), AND

FORMER ASTRONAUT GORDON COOPER (V.P. WALT DISNEY R&D). WE UNDERSTAND THAT THE PERSON RESPONSIBLE FOR BRINGING THE GROUP TOGETHER IS PRODUCER E. LEE SPEIGEL WHO HAS PRODUCED AN AUDIO VISUAL PRESENTATION WHICH WILL FOLLOW THE TESTIMONY OF THE "EXPERTS". ALL OF THE ABOVE LISTED PERSONS HAVE BEEN OFFICIALLY ACCREDITED TO THE UNGA BY GRENADA.

3. TWO MEETINGS HAVE BEEN ALLOCATED FOR THIS ITEM BY THE CHAIRMAN OF THE SPC. PRESUMABLY DELEGATES WILL BE GIVEN A DAY OR SO TO DIGEST THE INFORMATION PRESENTED AND THEN RETURN TO ACT ON THE RESOLUTION.

4. THUS FAR ONLY TWO COUNTRIES HAVE GONE ON RECORD WITH A POSITION ON THE GENERAL PROPOSAL. SEYCHELLES SUPPORTED THE IDEA WHILE INDIA REJECTED THE ESTABLISHMENT OF A SEPARATE UN AGENCY OR COMMITTEE BUT SUGGESTED THAT SOME DISCUSSION OF UFO'S COULD BE INCLUDED WITHIN THE BROADER CONTEXT OF THE "EXTRATERRESTRIAL LIFE/INTELLIGENCE" ITEM UNDER CONSIDERATION BY THE OUTERSPACE COMMITTEE. THERE APPEARS TO BE VERY LITTLE INTEREST ON THE PART OF MOST DELEGATES TO PURSUE THIS MATTER. NEVERTHELESS GRENADA WILL PRESS FORWARD UNDER INSTRUCTIONS FROM GAIRY WHO SEES HIS COUNTRY AS HOST OF A CENTER FOR UFO RESEARCH.

5. ACTION REQUESTED: PLEASE PROVIDE INSTRUCTIONS ON U.S. POSITION TO BE TAKEN IN THIS MATTER AS WELL AS DESIRED LEVEL OF VISIBILITY. LAST YEAR GRENADA REQUESTED OUR SUPPORT AND MISOFF HAD TO SCRAMBLE HARD BEHIND THE SCENES TO WATER DOWN THE RESOLUTION AND, IN EFFECT, DELAY A VOTE FOR ONE YEAR. ANOTHER CONSIDERATION IS WHETHER TO ISSUE A DISCLAIMER ON STATEMENTS MADE BY U.S.

1. THE GRENADIAN RESOLUTION (DATAFAXED TO DEPT EARLIER THIS WEEK) CALLS FOR THE CREATION OF A SMALL COMMITTEE OF EXPERTS TO REPORT ON A POSSIBLE FRAMEWORK FOR A STUDY OF UFOS. ALTHOUGH THIS REPRESENTS A SCALING BACK FROM THEIR EARLIER PROPOSAL FOR THE CREATION OF AN AGENCY OR DEPARTMENT OF THE UN, IT STILL DOES NOT APPEAR TO BE ACCEPTABLE TO THE US.

2. THE GRENADIAN MISSION IS CALLING ON AMBASSADOR PETREE FRIDAY, NOV 24 TO DISCUSS THEIR RESOLUTION AND REQUEST US SUPPORT. AMBASSADOR PETREE INTENDS TO USE THE FOLLOWING TALKING POINTS AT THAT MEETING:

A) WE REALIZE THAT THE CURRENT RESOLUTION MERELY CALLS FOR THE CREATION OF AN AD HOC WORKING GROUP OF SEVEN EXPERTS WHICH WOULD STUDY THE MATTER AND REPORT BACK TO THE SYG BY JUNE, 1979 THEIR RECOMMENDATIONS FOR AN OFFICIAL UN

STUDY ON UFOS.

B) ALTHOUGH THE COSTS FOR A SEVEN-MAN WORKING GROUP MIGHT NOT BE PROHIBITIVE, ANY UN STUDY IN DEPTH COULD EASILY RUN INTO MILLIONS OF DOLLARS.

C) CREATION OF A WORKING GROUP WOULD REQUIRE SECRETARIAT REVIEW AUTHORITY: SAM A. MOSKOWITZ

SUPPORT WITH CONCOMITANT PERSONNEL, TRAVEL, DOCUMENTATION, AND CONSULTATION COSTS.

D) OVERRIDING US POLICY IS NOT TO CREATE NEW INTERNATIONAL ORGANIZATIONAL ELEMENTS BECAUSE OF FISCAL IMPLICATIONS.

E) THEREFORE, THE US COULD NOT SUPPORT THE RESOLUTION IN ITS PRESENT FORM.

F) AS EVIDENCED BY THE LIMITED RESPONSE TO THE SECRETARIAT, THERE IS VERY LITTLE INTEREST IN THE ITEM AND GRENADA WOULD NOT WISH TO BRING THE MATTER TO VOTE AND CHANCE EMBARRASSING PM GAIRY.

G) GRENADA MIGHT WISH TO MAKE ITS DETAILED PRESENTATION TO THE SPC AND THEN ADJOURN DEBATE WITHOUT A VOTE.

H) ANOTHER ALTERNATIVE WOULD BE TO FORWARD THE RECORDS OF THE SPC DISCUSSION TO THE OUTER SPACE COMMITTEE FOR FURTHER CONSIDERATION.

I) AS A FINAL ALTERNATIVE, IT MIGHT BE SUGGESTED THAT AN INFORMAL GROUP OF INTERESTED COUNTRIES STUDY THE ITEM FURTHER ON THEIR OWN (WITHOUT SECRETARIAT SUPPORT) AND REPORT BACK TO THE SPC WHENEVER THEY HAVE RESULTS OR RECOMMENDATIONS.

3. MISOFF HAS CONTACTED UK, FRG, USSR, AND INDIAN REPS, NONE OF WHOM WANT TO SEE THIS ITEM GO ANY FURTHER THAN WE DO. ACCOMMODATE GRENADA'S INTEREST, WITHOUT CHANCING EMBARRASSMENT TO PM GAIRY, MIGHT BE TO ASK THE UNGA TO APPOINT AN INDEPENDENT RAPPOREUR TO STUDY THE MATTER AND REPORT BACK AT SOME LATER DATE. (FYI: APPARENTLY THIS STRATEGY HAS WORKED IN THE PAST WITH OTHER SIMILAR PROBLEMS.)

4. FRIDAY, WHO DID ALL OF THE TALKING FOR GRENADA, INDICATED THAT HIS DELEGATION WOULD BE WILLING TO WORK WITH THE U.S. TO FIND A MUTUALLY AGREEABLE APPROACH TO THE UNDERTAKING. WHEN TOLD THAT THE SINGLE RAPPOREUR APPROACH WOULD BE FUNDED BY THE SPONSORING COUNTRY RATHER THAN THE UN, HE VOICED AN INTEREST IN INVESTIGATING THE POSSIBILITY OF UTILIZING SECRETARIAT PERSONNEL FOR THE TASK.

5. THE DISCUSSIONS CONCLUDED ON AN AMIABLE NOTE WITH BOTH SIDES AGREEING TO CONFER AGAIN AFTER THE 27 NOV PRESENTATION AND BEFORE ANY ACTION WOULD BE TAKEN BY THE SPC. LEONARD

1. SUMMARY: AS ANTICIPATED, GRENADIAN PM SIR ERIC GAIRY
ADDRESSED THE SPECIAL POLITICAL COMMITTEE (SPC) ON
AGENDA ITEM 126 AND INTRODUCED A RESOLUTION (DATAFAXED)
WHICH WOULD ESTABLISH AN EXPERT GROUP TO SET GUIDELINES
FOR A UN STUDY OF UFOS. HE WAS FOLLOWED BY DR. FRIDAY
(MINISTER OF EDUCATION) AND FOUR OTHER SPEAKERS, ALL OF
WHOM ARGUED IN FAVOR OF A "UN CLEARINGHOUSE" FOR THE
EXCHANGE OF DATA AND COORDINATION OF RESEARCH ON UFOS.
THE SPEAKERS WERE SUPPLEMENTED BY A SHORT FILM WHICH
CONSISTED OF STILL AND MOTION PICTURES SPLICED TOGETHER
PURPORTING TO DEPICT ACTUAL SIGHTINGS OF UFOS. CONSIDERA-
TION OF THE ITEM WAS SUSPENDED TO PERMIT DELEGATES TO

IN AUSTRALIA SEEMED TO HIM TO BE A COMPELLING REASON FOR THE UNITED NATIONS TO "COME ALIVE TO ITS RESPONSIBILITIES AND TAKE A SERIOUS LOOK AT THE U.F.O. PHENOMENON TO WHICH PLANET EARTH HAS BEEN CONSPICUOUSLY EXPOSED SINCE 1947."

3. MR. FRIDAY READ OUT THE TEXT OF A RESOLUTION ADOPTED IN APRIL 1977, AT ACAPULCO, MEXICO, AT THE FIRST INTERNATIONAL CONGRESS ON UFO PHENOMENON, WHICH HAD ENDORSED GRENADA'S INITIATIVE TO BRING THIS MATTER TO THE ATTENTION OF THE UNITED NATIONS. IT WAS AGAINST THIS BACKGROUND, HE SAID, THAT THE GRENADA DELEGATION HAD INVITED SOME OF THE SCIENTISTS WHO HAD PARTICIPATED IN THE CONGRESS TO JOIN HIS DELEGATION TODAY IN ORDER TO SPEAK ON THE SUBJECT.

4. DR. J. ALLEN HYNEK (PROFESSOR OF ASTRONOMY AT NORTH-WESTERN) COMPLEMENTED GRENADA FOR HAVING THE COURAGE TO INTRODUCE THE SUBJECT AND THUS "TROD WHERE MIGHTIER NATIONS FEARED TO TREAD." HE WENT ON TO DEFINE THE PHENOMENON OF UFO'S SIMPLY AS "ANY AERIAL OR SURFACE SIGHTING, OR INSTRUMENTAL RECORDING (E.G. RADAR, PHOTOGRAPHY, ETC.) WHICH REMAINS UNEXPLAINED BY CONVENTIONAL METHODS EVEN AFTER COMPETENT EXAMINATION BY QUALIFIED PERSONS." A CARDINAL MISTAKE, AND A SOURCE OF GREAT CONFUSION, HE REMARKED, HAD BEEN THE ALMOST UNIVERSAL SUBSTITUTION OF AN INTERPRETATION OF THE UFO PHENOMENON FOR THE PHENOMENON ITSELF. HYNEK SAID THAT UFO

IN SIGNIFICANT NUMBERS, THESE REPORTS HAD BEEN MADE BY HIGHLY RESPONSIBLE PERSONS -- ASTRONAUTS, RADAR EXPERTS, MILITARY AND COMMERCIAL PILOTS, OFFICIALS OF GOVERNMENTS AND SCIENTISTS, INCLUDING ASTRONOMERS. HYNEK CONCLUDED BY POINTING OUT THAT THERE ARE MANY SCIENTISTS AND SPECIALISTS AROUND THE WORLD WHO ARE STUDYING THE UFO PHENOMENON BUT THEY HAD NO MEANS, EITHER GOVERNMENTAL OR PRIVATE, BY WHICH THEY COULD SHARE THE RESULTS OF THEIR WORK. HE SUGGESTED THAT THE UN CREATE THE NECESSARY FRAMEWORK TO PROVIDE THIS CAPABILITY FOR SCIENTISTS.

5. DR. JACQUES VALLEE (CURRENTLY AN AUTHOR OF SCIENCE FICTION) WAS THE NEXT SPEAKER INTRODUCED BY DR. FRIDAY. HE HAS SPENT FIFTEEN YEARS ANALYZING UFO REPORTS ON A COMPUTER AND CONCLUDED THAT DESPITE THE LACK OF CONCLUSIVE PROOF, THE UFO PHENOMENON IS REAL BECAUSE PEOPLE BELIEVE IT IS REAL.

HIS CONCLUSION WAS THAT THIS PHENOMENON HAD THREE ASPECTS: FIRST, PHYSICAL MANIFESTATION THAT COULD AND

WITNESSES AT THE SCENE EXHIBITED DISORIENTATION SYMPTOMS, A LOSS OF THE SENSE OF TIME, PARTIAL PARALYSIS OR LOSS OF VOLUNTARY MUSCLE CONTROL, AUDITORY AND VISUAL HALLUCINATIONS, EYE COMPLAINTS RANGING FROM CONJUNCTIVITIS TO TEMPORARY BLINDNESS, MASSIVE PSYCHIC REACTIONS AND LONGER-TERM EFFECTS SUCH AS DISTURBANCE OF SLEEP AND DREAM PATTERNS AND RADICAL BEHAVIOR CHANGES. HE WAS QUITE SURE NOT, AS THERE WAS NO MOVEMENT AND THE DURATION WAS MUCH TOO LONG. AS FOR MORTAR-LAUNCHED FLARES, THERE WAS NO EXPLOSION AND AGAIN NO DRIFT.

9. ANOTHER MORE SPECIFIC STORY CAME FEB. 3 FROM FRENCHMAN DOMINIQUE VARGAS BASED ON A SIGHTING NEAR ASADABAD, KUNAR, IN SEPTEMBER.
