Reference is made to Bureau letter to Richmond Field Division dated April 15, 1946, in the above matter.

Investigation at Leesburg, Virginia, revealed that although there is a Peoples' National Bank, there is not a Peoples' National Bank Building, in the sense of there being offices in such a building. The bank is a single building and occupies it entirely. Entrance to the bank is gained through large double doors in the center of the building. Anyone going through these doors would have to go into the bank, and any agents observing this person could see that he did enter the bank. There is no other entrance in the front of the bank building. The bank was not open on Thanksgiving Day.

A list of the bank employees was obtained and this list is as follows: BRUCE McINTOSH, President; O. I. THOMAS, Vice-President; W. S. JENKINS, Vice-President; T. FRANK OSBURN, Vice-President; ARTHUR S. JENKINS, Cashier; J. L. McINTOSH, Assistant Cashier; WILLIAM F. PEACH, Assistant Cashier; E. N. BRADFIELD, Trust Officer. Other employees are Mrs. ELIZABETH L. PHILLIPS, Mrs. LEILA H. GALLEHER, Mrs. HELEN RODERICK, Mrs. EVA G. McCABE, Miss RUTH ONISON, Mrs. HELEN M. JOHNSTON, ROSIER J. MITCHELL and W. F. AULT, Janitor. All employees have a key to the bank and could have been in there on Thanksgiving evening.

On the Northside of the Bank is the John Gill Radio Shop. Above this shop are two apartments. DAN CHAMBLIN, racehorse trainer and family reside in one apartment and N. B. EVERHART, a railroad worker, resides in the other. These apartments are entered by a door from the main street about thirty feet from the entrance of the bank. It is possible that HELEN TENNEY entered this doorway.

South of the Bank is a one-story building occupied by the Insurance firm of Paxon and Hawthorne. Mrs. GRISELDA FULTZ is employed there and N. B. HAWTHORNE is the only member of the firm.

There is, in Leesburg, a Loudoun National Bank which has offices over it. This building is situated about half a block from the Peoples National Bank, and on the opposite side of the street. In this

building there are two doctors, a Dr. B. A. BRANN, Nurse Miss JEAN KIRKPATRICK, and Dr. FRANK PURDELL SMOOT, Nurse Mrs. KATHLEEN FRY. There is also the office of the Agriculture Conservation Association. This business employs the following persons: ELIZABETH C. THOMAS, Miss DELL BASCUE, and RUBY ELIZABETH FOLMER. All three of these employees worked Thanksgiving Day, but closed the office at 4:00 P.M. There was no register for this building.

There is also included herewith information relative to a check made with the National Lumbermans Bank, Muskegon, Michigan, relative to any record of ALBERT EUGENE KAHN, as requested by the New York Field Office, by letter dated February 4, 1946. The following Agents of the Detroit Field Division participated in the surveillance of CEDRIC HENNING BELFRAGE during his stay in Detroit, Michigan, from 8:15 A. M. April 2, 1946 to 8:20 A. M. April 6, 1946: Fred G. Cook, Lawrence H. Nichols, Damon W. Pitcher, Bowen F. Rose, Norman B. Schmidt, Richard W. Smith, Mortimer C. Watson, Miller R. Weeda, Edward N. Wills and Charles L. Zink.

BELFRAGE arrived at Detroit, Michigan, 8:15 A.M. April 2, 1946 via the New York Central Railroad from New York City, New York. Immediately upon his arrival he proceeded to the residence of Reverend CLAUDE WILLIAMS, 181 McLean Street, Detroit, Michigan.

On this same date, BELFRAGE and Reverend WILLIAMS proceeded to the Offices of the Peoples Institute of Applied Religion, remained at this place during the afternoon and evening at which time a meeting was held and it was ascertained that the following individuals were present during this meeting. An unknown man, Reverend G. ARTHUR, CARL HAESSLER, FRANCES PRICE, JAKE SHELBY, MAYNE SHELBY, Reverend CLAUDE WILLIAMS, EDNA JOYCE WILLIAMS and D. HUNT. This meeting was adjourned at 11:30 P.M. and BELFRAGE returned with Mr. and Mrs. Reverend WILLIAMS to their residence at 181 McLean Street, Detroit, Michigan.

It is to be noted that BELFRAGE remained at the residence of Reverend WILLIAMS on all nights during his stay in Detroit with the exception of the night of April 5, 1946 when he slept in the Offices of the Peoples Institute of Applied Religion, 420 Transportation Building, Detroit.

On April 3, 1946 BELFRAGE and Reverend WILLIAMS were observed to leave 181 McLean Street and proceed to 420 Transportation Building where they remained from 2:30 P.M. to 6 P.M. when they returned to 181 McLean Street. It is to be noted that no contacts were made by BELFRAGE on this date other than with Reverend G. ARTHUR, who has an office at 420 Transportation Building and FRANCES PRICE, who also works at this office.

On April 4, 1946 BELFRAGE and Reverend WILLIAMS were observed to leave 181 McLean Street and arrived at 420 Transportation Building at 8:45 A.M. where they remained until 5:15 P.M., at which time they returned to 181 McLean Street. On this same date at 8 P.M. BELFRAGE accompanied by Mr. and Mrs. Reverend WILLIAMS were observed to leave 181 McLean Street and walk to the address of 39 Massachusetts Avenue where they remained until 10:30 P.M. It is to be noted that CARL HAESSLER resides at 39 Massachusetts Avenue, Detroit, Michigan.

Under date of April 5, 1946 BELFRAGE and Reverend WILLIAMS were observed to leave 181 McLean Street and proceed to 420 Transportation Building, arriving there at 8:35 A.M. At 2:30 P.M. BELFRAGE and Reverend WILLIAMS were observed to leave the Transportation Building and walk to the Offices of the Visual Training Company, also known as the Forbes Company, located at 815 Bates Street, Detroit, Michigan. They were observed to remain in these offices for approximately one and a half hours when they returned to 420 Transportation Building. At 7:15 P.M. BELFRAGE and Reverend WILLIAMS were observed to leave the Transportation Building and Reverend WILLIAMS was observed to enter a cab presumably to return to his home and that BELFRAGE, after a brief walk was observed to return to the Transportation Building where he remained over night in the Offices of the Peoples Institute of Applied Religion, sleeping on a cot that was located in the office of Reverend CLAUDE WILLIAMS.

On the date of April 6, 1946 BELFRAGE departed from Detroit, Michigan, via the New York Central Railroad, Train 50, Empire State Express, occupying seat #3 in pullman car W, holding tickets for Harmon, New York, scheduled to arrive Harmon, New York 8:58 P.M. April 6, 1946. It is to be noted that the activities of BELFRAGE while in Detroit, Michigan, were reported daily to the Bureau, Washington Field Office and the New York Field Office.

The files of the Detroit Field Division reflect the following information relative to persons contacted by BELFRAGE during his stay in Detroit:

Reverend G. ARTHUR

Reverend ARTHUR has been very active in the organization of the Peoples Institute of Applied Religion and he is to be placed in charge of the Detroit area for this organization when Reverend WILLIAMS moves the Headquarters of this organization to Birmingham, Alabama, during June, 1946. On February 25, 1945 a man identified as G. ARTHUR was listed as a member of the Communist Party and had pledged himself to recruit three new members.

CARL HAESSLER

On November 30, 1945 he was listed as a member of the Steering Committee of the Civil Rights Federation. He was incarcerated as a Conscientious Objector during the first World War and was imprisoned at Alcatraz. He is assigned FBI #75511. He is reported to have directed the Communist Party Workers School in Chicago and having managed the Federal Press in Chicago during 1924. He was listed as a Rhodes scholar and a professor of the University of Illinois during 1914 and affiliated with numerous Communist Party front organizations and active in Communist Party functions of the UAW during 1914.

1917-18 articles in the Milwaukee Journal Newspaper reflect that he was a Socialist connected with the Milwaukee Socialist Paper. He is listed as being active in numerous front organizations from 1932 to 1943 in Detroit, Michigan, and was also associated with the Civil Rights Federation during the race riots in Detroit, Michigan in 1943. Informants advise that during 1944 he was an Executive Board member of the Detroit Council for American-Soviet Friendship and that he handled publicity for State Senator STANLEY NOVAK, Communist collaborator during recent elections. He is also listed as having taught classes in labor journalism at the Highlander Folk School, Montigo, Tennessee, from August 21 to 26, 1941.

Informants advise further that during 1945 he was considered an old-time Communist who was well thought of, but not carried as an open member.

On April 22, 1945 he appeared as a sponsor for the Peoples Institute of Applied Religion, which is a well-known Communist front organization. On February 26, 1946 he is known to have edited and contributed articles to various small union papers. He is also listed as a member of the Publicity Committee for the Labor Press of the Detroit Council of Applied Religion.

FRANCES PRICE

Miss PRICE is listed as Field Secretary for the Peoples Institute of Applied Religion and is known to be very active in the affairs of this organization and is present daily at their Headquarters, 420 Transportation Building, Detroit, Michigan, where she does clerical and stenographic work for Reverend WILLIAMS and Reverend ARTHUR.

The files of the Detroit Field Division failed to reflect any information relative to an individual known as D. HUNT, who was observed at the Peoples Institute of Applied Religion Headquarters on April 2, 1946.

JAKE SHELBY

SHELBY is employed by the U. S. Rubber Company where he serves as President of Local 223 of the United Rubber Workers of America - CIO. Mr. SHELBY is also listed as a shop preacher for the Detroit Council of Applied Religion.

MAYNE SHELBY

MAYNE SHELBY, wife of JAKE SHELBY, believed to be identical with one M. SHELBY who is listed as a Communist suspect in the Detroit area on October 23, 1940.

Reverend CLAUDE CLOSSIE WILLIAMS

Reverend WILLIAMS, alias ~~JOHN GALEY~~, resided in Paris, Arkansas, for five years, beginning 1931, as a Presbyterian minister and it is alleged that he was active as a labor agitator and to have had charge of the Commonwealth College in Mena, Arkansas. He has also lectured and preached in Negro settlements, urging equality of Negroes and in 1935 he was run out of Paris, Arkansas, going to Fort Smith, Arkansas where he was involved in organizing of WPA workers on a strike. Organizers of this strike, including WILLIAMS, were arrested for barratry and convicted. However, an appeal was made and the case was dismissed. The Sheriff in Fort Smith, Arkansas, advised he raided WILLIAMS' home in 1935 and found numerous Communist books and a membership card reflecting that WILLIAMS was a member in the Socialist Party. On July 26, 1941 at Little Rock, Arkansas, through the Institute of Applied Religion, actively preached Communism and Negro agitation in Tennessee, Arkansas and Mississippi.

During 1940 WILLIAMS became organizer for the United Cannery, Organization, Packing and Allied Workers of America and also became Director of the Peoples Institute of Applied Religion. It is to be noted that WILLIAMS at one time admitted membership in the Communist Party under the name of JOHN GALEY, but claims to have severed all connection with this Party in 1938. The Institute of Applied Religion held a series of five meetings in Wilson, Arkansas, July 25, to 29, 1944 and WILLIAMS conducted meetings in which AYC organizers participated. WILLIAMS was arrested by the Memphis, Tennessee, Police Department August 8, 1944 for investigation, but was released the next day. At this time he gave a voluntary statement concerning his activities and denied any association with the Communist Party.

Attention is directed to a book entitled "South of God" written by SIEGFRIED BELFRAGE that purportedly outlines the life and work of Reverend WILLIAMS in the southern states.

The files further reflect that Reverend WILLIAMS signed an open letter to the President of the United States on March 5, 1941, urging that the constitutional rights of the Communist Party be maintained. Reverend WILLIAMS was assigned FBI #2399632. He is registered for Selective Service with Local Draft Board 2, Court House Annex, Evansville, Indiana, assigned serial #U-1168.

Reverend WILLIAMS also spoke at a Michigan CPA State Conference on April 26, 1945 and was given a testimonial dinner on May 4, 1945 by the Civil Rights Federation of Detroit. He was also observed to be in frequent contact with ~~JACK RASKIN~~, Executive Secretary of the Civil Rights Federation and a Michigan CP officer.

EDNA JOYCE WILLIAMS

EDNA WILLIAMS, wife of Reverend CLAUDE WILLIAMS, is listed as an Associate Director of the Peoples Institute of Applied Religion. It is to be noted that Mrs. WILLIAMS was present with BELFRAGE and Reverend WILLIAMS during their contact with CARL HAESSLER April 4, 1946.

Under the Visual Training Corporation, also known as the Forbes Company, a report of the U. S. Naval Intelligence Service, Ninth Naval District dated March 30, 1943 states that said Company is incorporated to make motion pictures, slide films and other media of training, educational and advertising products. Officers of said Company are listed as G. A. FLOREZ, President; D. S. BENEDICT, Vice-President; A. G. RIPPEY, Jr., Treasurer. This Company had several contracts for material to be used for educational purposes and to be used in explanation of materials used by the United States Government. The standing of this Company is listed as satisfactory and no derogatory information was listed.

Mr. PIERRE DROSTONG, Manager of the Transportation Building, who has previously been contacted by this office relative to the Peoples Institute of Applied Religion, advised that on April 5, 1946 while in the offices of the Peoples Institute of Applied Religion in the presence of Miss PRICE, BELFRAGE and Reverend ARTHUR, Reverend WILLIAMS stated that the main office of the Peoples Institute of Applied Religion was to be moved to Birmingham, Alabama, during June (1946). Reverend WILLIAMS further stated that he was going there to take charge and that Reverend ARTHUR would remain in Detroit to take care of the Institute's business in the Detroit area. Mr. DROSTONG also stated that Reverend WILLIAMS was also interested in a smaller and less expensive office for Reverend ARTHUR to enter the first of June (1946). Mr. DROSTONG advised that he explained he was unable to promise them new office space on such short notice, but he would consider them for a smaller office.

The New York Field Division by letter dated February 4, 1946 requested the Detroit Field Division to check the records of the Lumbermans National Bank at Muskegon, Michigan, for all information regarding financial transactions of ALBERT EUGENE KAHN, in which Bank KAHN was purportedly to have maintained an account during 1940 and 1941. On April 1, 1946, Mr. GEORGE W. HANSEN, Assistant Cashier, Lumbermans National Bank, Muskegon, Michigan, was contacted at which time a complete search of all records of this Bank under the name of ALBERT EUGENE KAHN was made with negative results. A check was also made at the Merchants Credit Service, Muskegon, Michigan, as well as the Identification Division of the Muskegon Police Department with negative results.

It is to be noted that there was no record of ALBERT EUGENE KAHN carried in the City Directory of Muskegon, Michigan, for the years 1940 or 1941.

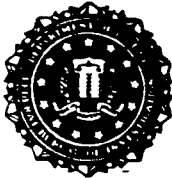

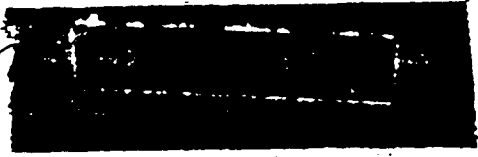

GEORGE N. PERAZICH, according to the records of the Clerk of the U.S. District Court at Buffalo, as exhibited by the Clerk, MARGARET MESMER, obtained United States citizenship at Buffalo, New York on September 3, 1942. He holds Certificate of Naturalization Number 5540089 and Petition Number 40356. MARGARET MESMER informed that PERAZICH filed this Petition for Citizenship as being the husband of a citizen, AMELIA IVANKOVICH PERAZICH.

According to the records, GEORGE PERAZICH at the time he received United States citizenship in Buffalo had the address 273 North Drive and his occupation was that of research engineer. The records reflected that he was born April 20, 1905 in Rezovichi, Petrovac, Jugoslavia. 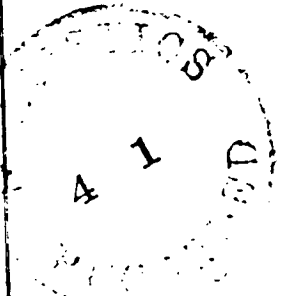

 details were known concerning the RADICH family other than that they owned
 the ranch on which they are living and have a good reputation in the
 community. VUKOVICH was stated to be about fifty-five years of age, while
 Mr. and Mrs. RADICH are both over 60.

VUKOVICH has carried a commercial account with the First
 National Bank of Crosi for a number of years. Its normal balance is
 in the low four figures and its activity is normal. No outside business
 interests on the part of VUKOVICH have been noted other than that he
 has financed several Filipino farmers occasionally. He is presently
 receiving forty dollars a month from relatives to whom he made a loan,
 the names of whom were not known. He has bought war Bonds regularly.
 VUKOVICH has a safety deposit box in the Crosi Bank but seldom uses it.

VUKOVICH is not known to have engaged in political activities
 of any sort nor is he known in his home community to be closely affiliated
 with any political group.

A search of the San Pedro directory, 1946 edition, reflects that FRANICHEVICH resides at 969 West Ninth Street. No occupation is given for this individual who rents his home. A spot check of these premises reflected the address is a bungalow court. In front of the court was FRANICHEVICH's car, a Buick, bearing California license 60-T-673. This was the same car in which individuals presumed to be FRANICHEVICH and his wife attended the farewell of GEORGE N. PERAZICH at Fresno, California, on January 14, 1946. Usually reliable sources in San Pedro and Wilmington were checked for information regarding FRANICHEVICH with negative results.

The records of the Retail Merchants Credit Association, Los Angeles, were also negatively checked.

Mr. H. I. OLIVER, manager, Credit and Adjustment Bureau, 1008 South Pacific Avenue, checked his records and made available information regarding FRANICHEVICH. These files showed an entry on December 21, 1943, of a notice of application for permit to conduct a public dance hall cafe at 209 West Sixth Street, San Pedro, in the name of GEORGE L. FRANICHEVICH and MARKO M. FRANKOVICH with "intention to sell alcoholic beverages".

The next entry on this file was September 12, 1944, at which time FRANICHEVICH sold his half interest in the Waldorf Inn, 209 West Sixth Street, to MARKO FRANKOVICH under bank of America's Tenth and Pacific Branch escrow number 25-4957. The last entry on this file reflected FRANICHEVICH is presently employed at the Alaska Inn, residing at 969 West Ninth Street.

The records of the Captain of the Port, Wilmington, were checked for a harbor pass for FRANICHEVICH with negative results. The records of the Los Angeles Police Department, San Pedro Division, were checked negatively and Captain H. L. EVANS and Detective TIM HARGET were interviewed for information regarding FRANICHEVICH with negative results.

The files of the Sheriff's Office, Los Angeles, were checked also with negative results. However, a card on file at the Los Angeles Police Department, Central Division, reflected GEORGE L. FRANICHEVICH, 969 West Ninth Street, San Pedro, made application for a license to operate a public dance hall and cafe on December 16, 1943. This card reflects that FRANICHEVICH was born in Petrovac, Yugoslavia. His nationality was given as American.

LAMB, JR., Manager, Associated Credit Bureau, 410 West Sixth Street, checked his records with negative results; however, these records reflected that one GEORGE FRANICHEVICH in February, 1938, succeeded JOHN MIRKOVICH as manager of the Fishermen's Cooperative Association. Further investigation disclosed, however, that this FRANICHEVICH is probably not identical with GEORGE L. FRANICHEVICH,

The gas turn-on records of Southern Counties Gas Company, San Pedro, were checked by O. R. C. GRI who advised that the order turning on service for FRANICHEVICH at 969 West Ninth Street, was effective October 1, 1943. No previous address and no references were shown on the application for service.

It was ascertained that ARNOLD and BRUCE ENDELMAN reside at 470 South Almont Drive, which property they purchased in July, 1945. The application for gas service was checked by Mr. WILLIAM McKEE, Southern California Gas Company, which reflects that the service was commenced on July 5, 1945, giving a mailing address for bills, 416 North Beverly Drive, which is the business address of this family. The account was in the name of ARNOLD ENDELMAN who was listed as the owner of the property. Previous address was stated to be "out of city" and no other information was shown.

The records of the Tax Assessor's Office, Los Angeles County, were checked at the Hall of Justice Building, Los Angeles, with negative results except that the previous owners were shown as ALEXANDER A. and VERA TORSH, 470 South Almont Drive.

[Source 2] advised that a check of his records reflected that the ENDELMANS formerly resided in Niles, Ohio, and carried a joint bank account at the Security First National Bank, Beverly Hills, which was opened June 18, 1945. This account was described as a "moderate four figure account" while another account in the name of BRUCE ENDELMAN was described as having a "small four figure account".

On July 1, 1945, the ENDELMANS were residing at the Georgian Hotel, Santa Monica, California, and stated they had just purchased the property at 470 South Almont and had been operating BRUCE'S DRESS SHOP, 416 North Beverly Drive, for approximately three weeks. This source stated that the ENDELMANS have been in Niles, Ohio, for three years operating a Bruce's Dress Shop there. This source stated that the ENDELMAN came to the United States as refugees in 1941 and he did not know whether they were naturalized. He stated that he had heard they had become United States citizens. He further advised that their business reputation is good and that they were considered successful merchants, having a net worth of approximately \$10,000 and a net income of \$8,000 to \$10,000.

[Source 2] further advised that the ENDELMANS are approximately sixty-five years of age and have one daughter living at home, age twenty-six. He said the family is Hebrew and that their associates are also of the Hebrew race.

This source also stated that they were fairly well known in Niles, Ohio, from their three-year residence in that city.

[Source 4] advised that ARNOLD ENDELLMAN was born in Warsaw, Poland, and that his mother's maiden name was RABINOVITZ. He stated that ENDELLMAN had advised he was operating under general license number 42 which was not blocked. Whether this referred to an export business, informant did not know.

This source further stated, however, that ENDELLMAN had opened an account with the Security First National Bank in Santa Monica on February 2, 1945, having previously had a checking account in Niles, Ohio, with the Niles Bank Company, which he used as a business reference.

[Source 3] also advised the Agent that ARNOLD ENDELLMAN and his wife, BRUCE, had purchased a dress shop which they operated under the firm name of Bruce's Dress Shop from HARRY FINER, 460 South Spalding Drive, on June 23, 1945, through IRVING I. TURNER at 909 South Los Angeles Street, who does business under Business Opportunities License Number 264, for a consideration of \$8,000 cash plus a \$4,200 mortgage.

The records of the Better Business Bureau, 742 South Hill Street, Dun & Bradstreet, Inc., Retail Merchants Credit Association, Los Angeles Police Department, Los Angeles Sheriff's Office and Immigration and Naturalization Service were all checked for the names of ARNOLD and BRUCE ENDELLMAN with negative results.

B. J. FIRMINGER, City Clerk, Beverly Hills, advised that under a new city ordinance, all businesses in Beverly Hills must be licensed. He stated that the license for Bruce's Dress Shop reflected gross sales for 1945 of \$18,000, showing ARNOLD ENDELLMAN as owner. Inspector Flynn advised that he did not know the exact date Bruce's Dress Shop opened but stated that it was since February, 1945, because Benson's Dress Shop was located at 416 North Beverly Drive at that time.

Mrs. Scott, of the Beverly Hills Chamber of Commerce, checked her records for information regarding Bruce's Dress Shop or its owners with negative results.

A spot check of the premises of 470 South Almont Drive showed that a 1941 Nash coupe was parked in front bearing 1945 Pennsylvania license number H 6556.

By letter dated March 11, 1946, to the Pennsylvania Bureau of Motor Vehicles, information regarding the registration on this car was requested.

On another occasion, a spot check reflected the presence in front of the house at 470 South Almont Drive of a 1941 Chevrolet coupe bearing California license 3 W 443 as well as a registered nurse's tag. This vehicle is registered to BETTY B. SLITH, 463 South Bentley Avenue, Los Angeles.

The name of BETTY SLITH was checked through the California State Registered Nurses Examining Board and the files of the Los Angeles County Health Department with negative results. The files of the Registrar of Voters, 808 North Spring Street, Los Angeles, were also checked for information regarding BETTY SLITH or the ENDELMANs with negative results.

By letter dated March 24, 1946, from the Bureau, a mail cover was authorized and placed upon the ENDELMANs at 216 North Beverly Drive, and 470 South Almont Drive, by letter from Los Angeles dated March 26, 1946. The results of this cover to date are set out below:

This application showed service in the name of Mrs. RUTH WEBER, 919 1/2 North LaJolla, beginning December, 1939, showing JOHN WEBER, writer, as reference, and reflecting a former address of 4829 Lemon Grove Avenue. Mr. LEE stated that service had been continuous since that date at WEBER's address. b7D

The records of the Registrar of Voters, 808 North Spring Street, reflected that JOHN WEBER was born in New York and registered May, 1944, giving his occupation as story editor.

Source 7 advised that JOHN WEBER was born April 5, 1910, at New York City, as ISIDORE WEINSTEIN and was married June 27, 1938, at New York City to his present wife, RUTH. This source indicated that WEBER was educated at the College of the City of New York for one year and one-half, Columbia University for one-half year, extension division. Source 7 further stated that WEBER had been employed by RKO and Paramount Studios as reader and assistant story editor before he went into the Army, stating he was inducted April, 1943, and assigned Army Serial Number 39571435, and was discharged November, 1944.

This source also advised that he went on a trip to New York from February 6 to February 28, 1943.

Source 2⁴⁴ was unable to furnish any information regarding JOHN WEBER.

WARREN that WEBER had been employed as a reader in the Story Department at RKO Studios from April, 1941, to August, 1941, when he resigned to take a position with Paramount Studios for more money. This source stated that WEBER had been in California about one year at the time he first went to work at RKO.

Source 9⁴⁴ advised Special Agent WARREN that he knew JOHN WEBER personally while he was employed at RKO and considered him of good moral character but did not know anything about his political beliefs as he was a reserved person who was quiet and did not comment on many things openly. This source stated that WEBER contracted a skin infection while in the Army which necessitated hospitalization in Pasadena, California, for several months prior to discharge from the Army.

Source 9⁴⁴ stated that he has heard WEBER is now employed by the William Morris Agency in Beverly Hills selling stories to motion picture studios.

Special Agent ELLETT McGAUGHEY received the following information from Source 10⁴⁴: WEBER was employed at Paramount Studios as a reader from August, 1941, to April, 1943, at which time he went into the Army. This source stated that WEBER did not return to Paramount following his discharge from the Army October, 1944, and that he was last heard of at the William Morris Agency, Beverly Hills.

Source 10⁴⁴ was unable to furnish any information regarding any clubs or organizations of which WEBER might be a member or regarding his political beliefs or activities.

The records of the Los Angeles Police Department and Los Angeles Sheriff's Office were checked for the name of WEBER with negative results.

A spot check of the premises at 919 1/2 North LaJolla Avenue, disclosed that this address is a garage apartment in the rear of a double bungalow. A 1935 Ford two-door sedan was parked on the street in front of 919. This car bore California license plate 14 H 771 which is registered to JOHN WEBER, 919 1/2 North LaJolla Avenue. It should be noted that RUTH WEBER, the wife of JOHN WEBER, is active in the Russian American Club, which is also the subject of a current investigation in the Los Angeles Field Division.

She received her education at Julia Richmond High School in New York. ELLIOTT presently resides at 12035 Querin Street, North Hollywood, and her former address was 1427 North Hayvenhurst.

The following investigation was conducted by the reporting Agent:

The files of the Retail Merchants Credit Association and the Retail Credit Company, Los Angeles, were checked with negative results as was the office of the Registrar of Voters, Los Angeles County, 808 North Spring Street.

WILLIAM McKEE, Southern California Gas Company, advised that a check of the records of the office reflected that service at 12035 Querin Street is in the name of GLEA I. SCHULTZ, who is listed as owner. McKEE advised that this account has remained unchanged since November, 1940. He stated that service at 1427 North Hayvenhurst Drive was in the name of DAN JAMES from October, 1940, to July, 1945.

A review of the material contained in the indices of the Los Angeles Field Division on this individual reflects other former addresses of FAITH ELLIOTT as being 1666 North Bronson, Hollywood, in July, 1944; 1286 Sunset Plaza Drive, February, 1944; 5939 Carlton Way, telephone Olympia 4747 in 1943; and 191 North Bentley Avenue, West Los Angeles, no date; and telephone number Hempstead 8397, no date.

The closest spelling to Anaheim Street in Wilmington is Anaheim. The residents at 128 East Anaheim are listed in directories as HUGO R. and PAULINE MOOD.

Information was furnished by LUDLOW SHONARD, JR. of the Southern Counties Gas Company that the gas service at 128 East Anaheim is in the name of H. R. WOOG, service having been connected June 1, 1945. The 1946 edition of the San Pedro-Wilmington city directory lists HUGO R. and PAULINE WOOG at 128 East Anaheim, giving HUGO WOOG's occupation as manager, Blackburn Hotel.

The files of the Retail Merchants Credit Association and Retail Credit Company, Los Angeles, were negative as were the records of the Los Angeles Sheriff's Office, Los Angeles Police Department, and Wilmington Division of the Los Angeles Police Department.

The office of the Captain of the Port at Wilmington was also checked negatively as were the records of the Registrar of Voters, 808 North Spring Street, Los Angeles.

KARL M. GIBBS, Long Beach Credit Association, Kress Building, Long Beach, advised that the files of his office reflect that HUGO R. WOOG and his wife, PAULINE, leased the hotel at 128 Anaheim, Wilmington, in April, 1945, giving as a previous address for the last ten years, 309 Insurgentes, Mexico City. Also shown as a former address was Acapulco, Mexico. GIBBS stated that WOOG had given as a bank reference the Citizens National Bank, Wilmington, and stated that he was buying furniture for the hotel which had been leased from LEWIS TASEN.

Source 18 was checked with negative results. This source stated that information might be obtained at a later date.

Source 19 advised that HUGO R. WOOG was born in Switzerland on November 8, 1898, and that his mother's maiden name was BRAUNSCHWEIG. This source advised that he had no information regarding WOOG's wife and stated that they had a daughter, JACQUELINE. Source 19 also advised that WOOG had opened an account at the Citizens National Bank at Wilmington in June, 1945, giving as a bank reference, Banco Commerciale, Mexico City, and stated that WOOG was introduced by LEWIS TASEN, operator of an Army and Navy Store at 126 East Anaheim. This source also advised that WOOG's daughter, JACQUELINE, had been employed by the Citizens National Bank for a time.

Source 20 stated that WOOG had been with The Siberia Company in Manchuria as manager until eight years ago when the firm failed. He stated that this company was a soy bean producer and marketer. This informant advised that WEBER had then gone to Shanghai, China, and just before the war went to Mexico. The informant stated that he, himself, had been in the Far East for a number of years and had spoken with WOOG of China but WOOG froze up when the conversation turned to Mexico and

would not speak of his sojourn in that city. This source stated that it was his understanding that WCOG's wife, PAULINE, was a White Russian whom WCOG had married in Manchuria. Source 20 stated that CHESTER R. LIEBER, manager of the Far Eastern Division of the National City Bank, New York City, had been a friend and business associate of HUGO WCOG for many years and had known him both in China and in Mexico. This source advised that LIEBER would be able to furnish more complete information regarding WCOG if such was desired.

Source 20 stated that WCOG claims Swiss birth but advised that he knew nothing of the citizenship status of this individual.

Source 21 stated that in July, 1943, HUGO WCOG was the manager of the Hotel La Marina, Acapulco, Mexico, and was a friend of CARLOS WALTER, manager of the Hotel La Riviera, Acapulco.

According to information obtained from Source 22, the address book of OSCAR CZBERKOFF DANCIGERS contained an entry, "WCOG, Gladstone 5265", during a visit in December, 1944, of DANCIGERS to Los Angeles from Mexico City. This telephone is listed to ROGER WCOG, 1423 North Curson Street, Hollywood. It may be noted that DANCIGERS is the subject of a pending Internal Security - R case in the Los Angeles Office.

Reference is made to the attached pink memorandum from Mr. Tamm to you dated April 25, 1946, concerning Alger Hiss.

As you recall Alger Hiss is a subject in the Gregory case and is presently employed as Deputy Director in the Office of Special Political Affairs, United States State Department. He is presently serving with the State Department on United Nations matters.

The Attorney General has received copies of memoranda concerning Hiss in the Gregory case entitled "Underground Soviet Espionage Organization (NKVD) in Agencies of the United States Government" dated February 21, 1946. This information was made available to the Attorney General on February 25, 1946. The Attorney General was also furnished a summary which contained information about Hiss entitled "Soviet Espionage in the United States" on December 4, 1945.

Alger Hiss was recently interviewed by an official of the Bureau at his own request, and the results of that interview were made available to the Attorney General on March 25, 1946, the same date upon which the interview occurred.

An up-to-date memorandum concerning the activities of Hiss was made available to you on April 16, 1946.

The investigation concerning the activities of Hiss is continuing as a part of the Gregory case, and all future information concerning Hiss' activities will be furnished to the Attorney General.
