



ADMINISTRATIVE DETAILS

Attention of offices receiving copies of this report is called to the Bureau's instructions that investigation of the activities and contacts of Subject URSULA IRENE WASSERMAN must be carried out with full discretion and that "no informant should be used who is known to be or suspected to be pro-Soviet, pro-Communist, or professing anti-Fascist". (u)

The Bureau has further instructed that no dissemination of information received from the Bureau or information developed regarding Subject WASSERMAN is to be made without specific Bureau authority except the authorization to discreetly discuss the case with [redacted] if necessary or advisable. (S)

[redacted], who was interviewed regarding any information he might have concerning Subject WASSERMAN, was contacted on the basis of his original claim that Subject WASSERMAN was suspicious which he reported to a representative of the Office of the Legal Attache, Buenos Aires. No indication was given [redacted] of the basis of the Bureau's interest in accordance with Bureau instructions. b7c b7D

[redacted] was not directly contacted by this office. She was warned by [redacted] to be extremely careful in her dealings with Subject WASSERMAN and was told by [redacted] to report any information of interest concerning Subject WASSERMAN to the Office of the Legal Attache as he, [redacted] was suspicious of her activities. b7c b7D

Bureau advised that [redacted] was an applicant for position of Special Agent in the Bureau on June 22, 1942 at Washington, D. C. He was disapproved on the basis of him then being a citizen of Belgium and not of the United States, and further on the basis of objectionable contentious personality. b7c

It was stated that WASSERMAN's address book contained names, addresses, and telephone numbers of several known Soviet espionage agents and the following names and addresses in Latin America:

It was further stated that Subject WASSERMAN carried letters dated February 6, 1946 from BELLE MAYER, General Consul's Office, Department of State, to CHARLES GUTWIRTH and Miss SUE BURNETT, United States Embassy, Buenos Aires; and a letter dated February 16, 1946 from HANS FREEMAN, Tass Telegraph Agency, U.S.S.R., in New York, enclosing a letter of introduction from FREEMAN to GREGORE STEPANIAN, Tass correspondent, Montevideo, Uruguay. (u)

The Subject WASSERMAN was reported to be carrying a copy of the initial page of a book entitled "The Black Book" published by Jewish Communist Front organizations including the Jewish Anti-Fascist Committee, Moscow. It was stated that WASSERMAN apparently assisted in editing "The Black Book". (u)

It was stated that Subject WASSERMAN entered the United States on February 23, 1939 and became a naturalized United States citizen on August 1, 1944. She was traveling on United States Passport No. 128716 issued at Washington, D. C. on December 20, 1945. The parents of Subject WASSERMAN were said to reside in Buenos Aires; a brother, ERNEST WASSERMAN, residing 1906 Melian, Buenos Aires, and a married sister, LISETTE DANIEL, residing in Buenos Aires. Also a sister, ERICA MATNEK, was in 1943 an employee of the Czechoslovakian Legation in London. (u)



INFORMATION CONCERNING RELATIVES OF SUBJECT WASSERMAN, HER
CONTACTS, AND PERSONS LISTED IN HER ADDRESS BOOK

RELATIVES

PROFESSOR DR. MARTIN WASSERMAN: Data obtained by reliable confidential Source K reflects that in November, 1942 an investigation was conducted to determine the identity of PRUDENCE SIEDTS who was receiving mail care of "WASSERMAN, Melian 1906, Buenos Aires". It was stated that information was received that PRUDENCE SIEDTS or her husband had been connected with the publishing of a German news letter.

Investigation reflected that Dr. MARTIN WASSERMAN occupied the fourth floor of the building located at Melian 1906 and had resided there two previous years. It was ascertained that PRUDENCE SIEDTS did not live there but stayed in an apartment with Dr. WASSERMAN a major portion of the time. In the investigation it was further ascertained that Dr. WASSERMAN was Jewish and was reputed to have had a large fortune in Germany, his native land. He was reported to live very comfortably. He received a large volume of mail including many magazines. Dr. WASSERMAN was described as being elderly, short, typically Jewish, and deaf. No derogatory information concerning Dr. WASSERMAN was developed in the neighborhood. He was regarded in the neighborhood as being a former Professor of Literature and History in Hamburg, Germany. He was stated to be the uncle of the owners of the commercial firm J. WASSERMAN Y CIA, Bartolome Mitre 226. It was ascertained that Dr. WASSERMAN had not taken part in the affairs of the Jewish community in Buenos Aires and was considered somewhat a mysterious person.

It was reported that Dr. WASSERMAN rented Post Office Box 500 at the Belgrano Post Office but had arrangements with the Postman to unlock the mailbox and bring the mail to the apartment each day. The visitors at Dr. WASSERMAN's apartment appeared to be of the Jewish race and only a few of them could speak Spanish. Dr. WASSERMAN's mail reflected that he confined his activities more or less to Jewish circles.

LISELETTE WASSERMAN DE DANIEL: She is a sister of Subject WASSERMAN and is married to MAX DANIEL. They reside at Loreto 1717 and it is thought they have one or more small children.

MAX DANIEL also known as MAXIMO DANIEL: He is the brother-in-law of Subject WASSERMAN and married to her sister, LISELETTE. Reliable Source D reported that he is an Austrian, forty-nine years of age, resident of Argentina for the last eight years, a doctor of Economic Science. In Europe he was said to have been employed in a large American Petroleum Company. He is a Director of the firm Walemas, a chain of stores similar to Woolworth chain, with administrative offices at Rio Bamba 1124 and principal store located at Rivadavia 6928. The president of the company is BERNARDINO SUALDO, an Argentine; vice-president is LANSING WILCOX, an American; director is EMILIO LOPEZ, an Argentine; another director is ARTURO HILLEGAS, Argentine. Each of these officers with the exception of DANIEL have other business interests.

ERNESTO WASSERMAN also known as ERNEST: He is a brother of Subject, reported to be married, and resides at Avachco 2171, fourth floor, with his wife and her parents, ERNESTO HESS and wife. ERNESTO HESS has a son named; HERMAN HESS, who is one of the officials of the Cia Transatlantica Exportadora, S. A. with offices located on calle 25 de Mayo 158, fourth floor. ERNESTO HESS is reported as a German Jew who is in the tobacco business owning a tobacco factory.

(Source) furnished data reflecting that J. WASSERMANN Y CIA, importers and wholesalers of news print, have offices at Bartolome Mitre 226. This company was organized in 1936. The firm is presently operated by Dr. ERWIN J. WASSERMANN and MARIO WASSERMANN. Dr. ERWIN WASSERMANN owns 900,000 pesos (\$225,000. U.S.) of the million pesos capitalization and MARIO WASSERMANN 100,000 pesos (\$25,000. U.S.). Dr. ERWIN J. WASSERMANN receives the monthly remuneration of 3,000 pesos (\$750. U.S.) and MARIO WASSERMANN receives 625 pesos (\$156.25 U.S.). The profit is distributed between the partners in proportion to their respective contributions. The original capital of the company was contributed by ERWIN J. WASSERMANN and BRUNO JOHN WASSERMANN and GUSTAVO ELSNER. In September, 1939 partner GUSTAVO ELSNER died and at the same time BRUNO JOHN WASSERMANN retired.

Dr. ERWIN J. WASSERMANN, the son of ERWIN J. WASSERMANN now deceased, is a German, naturalized Argentine, married, age about forty-three with many years residence in Argentina. He has been Consul of Argentina in Washington, United States. He also has real estate interests being interested in the Cia. Argentina de Bienes Raices. MARIO WASSERMANN, an Argentine, single, age approximately thirty-three years, is a brother of Dr. ERWIN J. WASSERMANN. They are the exclusive agents of St. Maurice Valley Paper Company of Montreal, Canada. The company has an excellent credit standing.

CONTACTS OF SUBJECT WASSERMANN

CHARLES GUTHRIE: - Is an agent of the Treasury Department of the United States and is presently attached to the United States Embassy at Buenos Aires. He arrived in Buenos Aires approximately November, 1945 for the purpose of

He was reported to have become a member of the Communist Party of Argentina in 1938 and in 1940 was placed in charge of the administration of the Communist daily newspaper "La Hora" which position he is alleged to have held until March, 1942. In Buenos Aires HAYNES was also engaged in business having various representations and represented several North American firms in the import and export of chemical products. His office was located at calle 25 de Mayo 158. He is active in various political movements among which were Accion Argentina, Comision Pro-Union Nacional, La Liga Argentina Por Los Derechos Del Hombre. The latter two were Communist dominated organizations.

In September, 1945 DUNCAN A. HAYNES SR. was reported to be residing at 308 West 107 Street, New York City and was connected with the South American branch of ARTKINO PICTURES, INCORPORATED, 723 Seventh Avenue, New York City. He is known during 1944 and 1945 to have carried on extensive correspondence with the Argentine Communist leader RODOLFO CHIOLDI. [REDACTED]

He stated: "I wish to confirm my telephone conversation during which you made known to me that my call to Buenos Aires had nothing to do with the administration of the business, but with personal business regarding my father."
