A reliable Government official has stated that during the hearings of the Senate Committee on Atomic Energy on April 8 and 9, 1946, held in Washington, D. C., Byron S. Miller was present for the purpose of presenting legislation suggested by the Federation of Atomic Scientists in Washington, D. C. It was determined at this time that Miller was working under James R. Newman. Newman was also present at these hearings and appeared to be on the staff of the Committee, possibly as an associate of Dr. Edward U. Condon. The original draft of legislation submitted by Miller on behalf of the Federation of Atomic Scientists contained numerous loopholes inasmuch as it restricted any violations of law to the wilful communication or transmission of secret data and based the penalty upon the degree of intent, also making the crime dependent upon the successful commission of the offense to the point where an actual advantage is secured by a foreign nation.

Byron Miller is a known acquaintance of William Walter Remington, who has been identified as a Soviet espionage agent who acted on behalf of the Soviets while an employee in the United States Government from approximately 1941 to 1944. (65-56402-1166)

DONOHUE of the Bureau on August 22, 1946, advising that the Bureau had given approval for the installation of a microphone surveillance on the apartment of ABEL ROLF PLENN, who resides in Apartment 6 at 1511 Park Road, N. W. (C) u

On August 23, 1946, Special Agents ROBERT KURTZMAN and FRANK STONE of this office made an inspection of [redacted] and concluded that a briefcase detectaphone would be the most feasible type of microphone coverage. This can be done by [redacted] in [redacted] (C) u

[redacted] is expected to return to Washington on September 1, 1946. (C) u

It is, therefore, contemplated that a briefcase detectaphone will be used upon occasions and, as the situation demands, for some time in the future. (C) u

It is also contemplated that up until September 1, 1946, it will be used only when it appears that the use of such a microphone would be productive from an investigative standpoint. (C) u

The Bureau will be advised upon all occasions when the microphone has been used. (C) u

WHITE REFERRED TO LETTER WHICH HE SAID WAS VERY IMPRESSIVE. FISHER STATED QUOTE HARRY, WAIT UNTIL YOU SEE THE SEPTEMBER TWELVE SPEECH HE IS GIVING IN NEW YORK BEFORE NCPAC, MADISON SQUARE GARDEN. IT WILL TAKE THE LINE FROM THERE. IT GOES FARTHER EVEN AND TALKS ABOUT WHAT HE THINKS OF THE BRITISH. Reference is made to the Washington Field Division letter dated August 21, 1946, addressed to the Director. In this letter attention is called to a conversation between CARL GREEN and ERNA ROSENBERG, wife of subject ALLAN R. ROSENBERG. CARL GREEN indicated in this conversation that one MACK (phonetic) was bound for Europe in the latter part of August as a special legal counsel on a special problem to General LUCIUS CLAY. GREEN remarked that "MACK" was "taking just one or two people but he wants them like (ALLAN ROSENBERG).")

In the letter of reference, belief was expressed that CARL GREEN, in making this remark, meant that "MACK" wanted assistants espousing the same Communist principles as ALLAN ROSENBERG.

Please be advised that there are the strongest reasons to believe that "MACK," mentioned in the letter of reference, is MAX LOWENTHAL, who left Washington, D. C., for Europe on the 8:30 P. M. plane on August 26, 1946. Apparently he traveled on this plane unaccompanied by any assistants. His travel orders showed that he was proceeding as Advisor on Problems of Internal Restitution, Sequestration and Disposal of Jewish Property and was directed to proceed by air on or about August 26, 1946, from Washington, D. C., to Paris, France, on temporary duty for approximately five days and thence to proceed to Berlin, Germany, on permanent duty. (MAX)

MAX LOWENTHAL was seen off at the airport by a woman believed to be his wife; by DAVID B. WAHL, a subject in instant case who is head of the American-Jewish Conference, Washington, D. C.; by HERBERT A. FIERST of the State Department; and by Mr. and Mrs. EDWARD COOPER of 3526 Quebec Street, N. W.

In the course of this conversation, CARL GREEN stated MACK (phonetic) was leaving in about a week for Europe on a special mission for President TRUMAN as "special legal counsel on a special problem to General LUCIUS CLAY." GREEN stated MACK would be gone for about a month on this trip. He remarked, "Your husband saw him and will give you a full report on that. He is taking just one or two people but he wants them like (ALLAN) ROSENBERG."

DEFERRED RECORDING

In view of the difficult conditions faced by General CLAY in Germany owing to the Communist problem, it is believed of particular interest to the Bureau that a man entertaining Communist principles should have an opportunity to exercise important influence in General CLAY's area in Germany. It is believed that CARL GREEN in stating that MACK wanted one or two assistants like ROSENBERG had reference to ROSENBERG's ardent Communist persuasions.

The following educational and employment information relative to MITSCHRICH was furnished by the Bureau in requesting such investigation:

MITSCHRICH was employed by the Moloney Electric Company, 5390 Birch Boulevard, St. Louis, as a transformer designer from October, 1917, until the present time at a salary of \$9750 per year. He was arrested in St. Louis for speeding December 26-1936. MITSCHRICH was employed by Westinghouse Electric Company, East Pittsburgh, Pennsylvania as a student apprentice and transformer designer from June, 1913, to October, 1917, at a salary of \$1500 per annum. MITSCHRICH attended Oklahoma A & M College at Stillwater, Oklahoma from September, 1909, to June, 1913, receiving a BS Degree in the latter year.

It should be pointed out that in connection with the investigation requested of MITSCHRICH by the Bureau, there was investigation also conducted by the Pittsburgh and Oklahoma City Field Offices, the results of which are not known to the St. Louis Field Office.

By report of Special Agent J. T. SANFORD dated April 4, 1942, at St. Louis, Missouri, and entitled MELVILLE F. MITSCHRICH, Office For Emergency Management, Special Inquiry, the following background information relative to MITSCHRICH was submitted to the Bureau:

Mr. T. A. BRENNAN, Personnel Manager, Moloney Electric Company, 5390 Bircher, St. Louis, Missouri, advised that Mr. MITSCHRICH had been with the company for about twenty-five years. He is very highly regarded by Mr. BRENNAN and by all the employees of that company. He stated he is one of the finest men he knows. He further stated that Mr. MITSCHRICH is a man of excellent character and integrity and is completely loyal to this country in every respect. He said that if "they were all like 'MITSCH' the country would be all right". He was employed by that company in October, 1917, and he is a transformer designer and is Vice-President of the company.

Mrs. CHARLES SCOLLAY, 4530 Tower Grove Place, St. Louis, said that she had known Mr. MITSCHRICH for a good many years, since she has been living at that address. She said that he had an excellent reputation in the neighborhood, and was a very fine neighbor. She said that she thought he was a patriotic citizen because he is very much concerned about doing his part to help win the war. Mrs. SCOLLAY, who is a widow, states that he has been very nice to her and often takes her riding along with his family.

Mrs. BERTHA LECOUTOUR, 4535 Tower Grove Avenue, and Mr. JACK SECREST, 4536 Tower Grove Avenue, stated that they consider Mr. MITSCHRICH a very fine neighbor and advised he has an excellent reputation in the neighborhood and is a loyal American citizen, very much interested in doing his part in the war effort.

Miss LEE SIMON checked the records of the Commercial Rating Company, St. Louis, for a credit rating of applicant which disclosed that he has an excellent credit rating.

An examination of the St. Louis telephone directory for June, 1946, discloses the following listing: M. F. MITSCHRICH, 4532 Tower Grove Place, Telephone Prospect 1025.

An examination of the 1946 City Directory for St. Louis discloses that the following listings are contained therein: MELVILLE F. MITSCHRICH (Vice President), JENNIE E. MITSCHRICH, and JEAN M. MITSCHRICH (Student), all listed as residents of 4532 Tower Grove Place. It should be noted that there is no other listing in either the St. Louis telephone or city directory under this surname.

A telephone call under pretext was made to the Moloney Electric Company and reporting agent was informed that MELVILLE F. MITSCHRICH is still affiliated with such company and serves in a capacity of salesmanager and vice president.

Copies of this report are being forwarded to the Washington Field Division for information in view of the fact that the subject matter dealt with in this report relates to a subject in this case under investigation by the Washington Field Division.

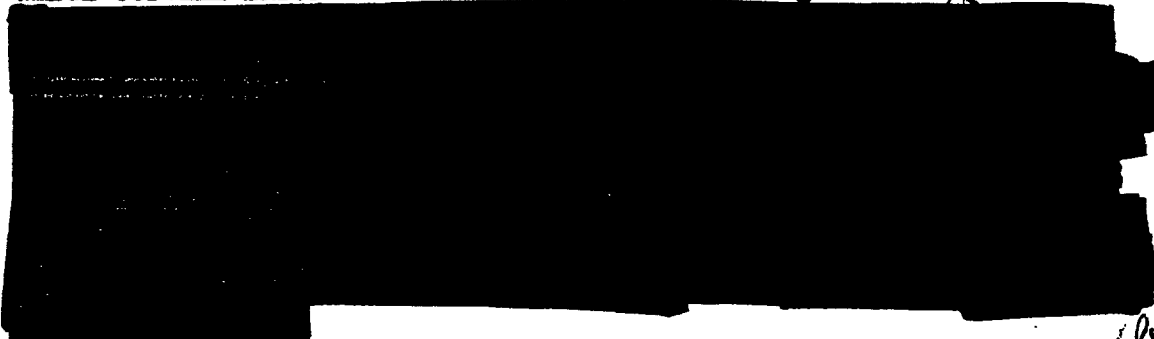

commonly uses the name of GEORGE SILVERMAN, had left New York via Flight 806 of the Northeast Air Lines destined for Boston. Agent POWELL furnished a description of SILVERMAN and requested that surveillance be made to ascertain his contacts while in Boston.

GEORGE SILVERMAN arrived at 12:00 noon August 3 via Northeast Air Lines and proceeded to the room of his son, RICHARD A. SILVERMAN, Lowell House, C-23, Harvard University. He was met at the airport by Special Agents JOHN LEAHY and JOHN MEHOS and was observed taking the subway to Cambridge and subsequently arrived at Lowell House. For the information of the Bureau, the Lowell House is one of the largest Harvard dormitories, housing approximately 400 students. It is a four-story brick structure which takes in an entire city block. The interior quadrangle or court can be reached through multiple entrances from the dormitory proper, or through four main gates on four different streets. RICHARD A. SILVERMAN occupied C-23, which was on the second floor overlooking the front of the building and also with one room facing the Harvard Gymnasium. RICHARD SILVERMAN is actually occupying a suite of rooms designed for two students. This includes two bedrooms, a bath, a study room and a living room with an interior hall connecting the four rooms. In this position, SILVERMAN is capable of observing any automobiles which may be conducting a surveillance upon him.

GEORGE SILVERMAN and his son on August 3, 1946, were observed by the aforementioned agents dining at 13-A Hudson Street, Boston, Mass., which is the How Yen Hon Chinese restaurant. As a matter of interest, on Sunday, July 21, 1946, SOLOMAN ADLER, whose activities in Boston were reported by Special Agent LAWRENCE G. HEALEY under date of 7/26/46, accompanied by RICHARD SILVERMAN, visited this same Chinese restaurant at 13-A Hudson Street, Boston, Mass. According to the agents who observed the activity of ADLER at that time, it was obvious from their actions that they had not been to this restaurant before. It was noticed that they walked past the How Yen Hon and entered another restaurant, apparently to determine the location of the How Yen Hon. Agents advise that this restaurant is of very low class, apparently frequented only by the Chinese. During the hour and a half ADLER and RICHARD SILVERMAN stayed there, a Chinaman stood outside the restaurant and appeared to act as a lookout. As they emerged from the canopy-covered entrance, ADLER appeared to be shaking hands with someone. No one appeared to have sat at the table with them.

The Boston Street Directory lists 13-A Hudson Street as the Yen Hon Restaurant. However, no name appears over the entrance.

On the same day, August 3, 1946, GEORGE SILVERMAN and his son were observed calling at 1215 Blue Hill Avenue, Mattapan, Boston, which is the home of DAVID SILVERMAN. (This individual has previously been reported by Special Agent BRENTON S. GORDON of Boston 6/12/46). Apparently finding no one home, GEORGE SILVERMAN proceeded on foot to 54 Westmore Road, Mattapan, which is the residence of PHILIP SLEPIAN, also identified in the report of Special Agent BRENTON S. GORDON dated 12/21/45 in the GREGORY case. They returned to Lowell House at 10:30 p.m.

Inasmuch as no instructions had been received concerning the type of surveillance to be conducted, a teletype was forwarded to the Bureau, Washington Field, and New York City on August 4, 1946, advising that a discreet spot check surveillance was being maintained unless advised to the contrary.

On August 4, 1946, Agents LEAHY and MEHOS observed SILVERMAN and his son taking a walk at 11:30 a.m., at which time the son pointed to the building at 19 Ware Street, Cambridge, which has been previously identified as the home of LAWRENCE RICHARDSON, at which location SOLOMAN ADLER stayed over the weekend of July 20, 1946.

At 1:30 p.m. on August 4, SILVERMAN proceeded alone by street car to the home of DAVID SILVERMAN, 1215 Blue Hill Avenue, Mattapan, where he remained approximately 45 minutes. Then he proceeded to 19 Balsam Street, Mattapan, accompanied by an individual believed to be DAVID SILVERMAN. At this address, he remained for approximately one-half hour, after which he returned by subway to Lowell House at 4:45 p.m.

At 19 Balsam Street, Dorchester, there are listed five individuals in the telephone book and City Directory as follows:

PHILIP MALTZ, laborer, telephone GENEVA 0746, Apartment 1. There is no record in the Boston Field Division concerning this individual.

No record except a letter from the Boston Office dated 4/7/41 sending an application for the position of Special Agent (A) in answer to his request. It was stated therein that LEVENSOHN was a graduate of the Bentley School of Accounting and Finance.

O'BRIEN and JOHN DESMOND observed SILVERMAN and his son dining at the Oxford Grille, 38 Church Street, Cambridge, Mass., returning to Lowell House at approximately 6:30 p.m. At 10:30 p.m., SILVERMAN and his son went for a walk to St. Clair's Restaurant in Harvard Square, returning to Lowell House at approximately 10:45 p.m.

Under date of August 5, 1946, T-1 advised reporting agent he believed GEORGE SILVERMAN had left Lowell House, and suggested T-2 be contacted for verification. However, it was ascertained T-2 would not be available for interview until the following day.

On August 6, 1946, Special Agent JOHN MEHOS and the reporting agent contacted T-2, who advised RICHARD A. SILVERMAN had told her the previous week that his father was going to stay at the Lowell House for the weekend. Agents had occasion to enter the suite of rooms occupied by RICHARD A. SILVERMAN during the course of this interview, and it was definitely ascertained that no one had slept in the extra bed the previous night. The gladstone bag of the father, GEORGE SILVERMAN, was not in this suite of rooms. T-2 advised that she was not working at Lowell House until Monday morning and had not observed GEORGE SILVERMAN. However, she had observed that the extra bed had been used over the weekend.

Accordingly, a teletype was forwarded to the New York and Washington Field Divisions advising that GEORGE SILVERMAN had probably returned home, and the surveillance at Boston was terminated.

Stops which have been placed at railroads and airlines by reporting agent on August 3, 1946, were removed.

RICHARD A. SILVERMAN

Under date of July 22, 1946, the Washington Field Division requested background information concerning the person in whose name is listed the telephone number ELIot 9326.

Inquiry at the local telephone company reflected that this number is assigned to a pay station at Lowell House, Harvard University, Cambridge, Mass. Special Agent JOHN A. MEHOS interviewed the superintendent of Lowell House, DENNISON SEXTON, who advised that most of the students living there have telephones available near their rooms and rarely find it necessary to use the pay station. It is the only booth in Lowell House and is located in front of the dining hall. SEXTON pointed out that when this telephone rings it cannot be heard by any of the students in their rooms. Consequently he suggested that anyone calling that number from outside would probably do so only after making arrangements with another individual to receive the call at an appointed time.

Attention is called to the report of Special Agent LAWRENCE G. HEALEY, dated July 26, 1946, at Boston, in the GREGORY case. Of possible significance is the fact that when SOLOMAN ADLER was in Cambridge, Mass., on July 20, 1946, he attempted to contact one RICHARD A. SILVERMAN at the Lowell House and it was later learned that SILVERMAN, who is a student at Harvard University, gave his residence address as 2395 Fifth Street, N. W., Washington, D. C.

Under date of August 1, 1946, Special Agent JOHN A. MEHOS checked the records office at Harvard University, which reflected that RICHARD A. SILVERMAN is taking the following subjects at Harvard University:

Physics 33, Wednesdays, 2:00 p.m., 256 Jefferson Hall
Slavic 11-A, Mondays and Fridays at 11:00 a.m. and Mondays and
Thursdays, 2:00 - 3:30 p.m. at Seaver A, Harvard University

During the time Agent MEHOS and reporting agent observed RICHARD SILVERMAN's suite of rooms, it was noticeable that his reading material did not include Communistic or other inflammatory reading. His entire library, which was considerable for a student, included either texts or English classics.

BESSIE WHITE BLOOM, aka Mrs. HENRY H. BLOOM

The following investigation was conducted by Special Agent WILLIAM J. MCCARTHY at Boston, Mass.:

The 1946 telephone directory for Boston and Brookline lists HENRY H. BLOOM, 59 Baxter Road, Brookline, telephone LONGwood 6639.

The 1944 City Directory of Brookline lists HENRY H. BLOOM, 59 Baxter Road, Brookline, as a Commission Merchant. His wife is listed as BESSIE BLOOM. Two other individuals are also listed as residents at 59 Baxter Road, a son, DAVID ALAN BLOOM, U. S. Navy, and JOSEPHINE BLOOM, student, probably a daughter.

The 1945 Boston City Directory lists HENRY H. BLOOM, President of Dench & Hardy, a concern engaged in being Commission Merchants, handling fish.

The files of the Boston Field Division reflect that during the investigation of the case entitled "LOBSTER INVESTIGATION, ANTITRUST," it was established that HENRY H. BLOOM was the President of Dench & Hardy, a concern engaged as Commission Merchants handling lobster exclusively, the concern doing a gross business of above \$200,000 a year. The concern was formed in 1909. In 1945 it became a partnership between HENRY H. BLOOM and H. B. DIBBINS. It was ascertained during this investigation that HENRY H. BLOOM's son, SAMUEL H. BLOOM, was a Commission Merchant dealing in fish and lobster. He owned the concern of Crocker & Winsor.

The files also reflected that by letter dated December 4, 1943, the New Haven Field Office advised the Boston Field Office that a DAVID ALAN BLOOM, 59 Baxter Road, Brookline, Massachusetts, had filed an application for entrance to Yale University for 1943. He stated in his application that he was born December 3, 1925, in Boston, and that his father's name was HENRY HYMAN BLOOM, born in England, and entered the United States in 1892, and was a naturalized citizen. He gave his mother's name as BESSIE WHITE BLOOM, born in England, entered the United States in 1889, and was a naturalized citizen.

The records of Immigration and Naturalization Service, 73 Tremont Street, Boston, Massachusetts, were checked relative to both HENRY HYMAN BLOOM and BESSIE WHITE BLOOM with negative results.

The records of the Bureau of Vital Statistics, State House, Boston, Mass., were checked relative to the marriage of HENRY HYMAN BLOOM and BESSIE WHITE BLOOM and reflected that they were married on December 29, 1912, in Boston, Massachusetts. The groom furnished the following information:

Other than the above references, the indices of the Boston Field Office were negative relative to BESSIE WHITE BLOOM, HENRY HYMAN BLOOM, DAVID ALAN BLOOM, JOSEPHINE BLOOM, and SAMUEL H. BLOOM.

ABRAHAM WHITE

Reference is made to the letter from the Washington Field Division captioned "HARRY D. WHITE," requesting the listing for telephone number Wellesley, Mass., 3782. This letter further advised that on April 15, 1946, HARRY WHITE contacted an individual believed to be one A. WHITE, 41 Tepsan Road.

Reporting agent ascertained that this telephone number is listed to ABRAHAM WHITE of 41 Tennyson Road, Wellesley, Mass., which is apparently the individual in question. In this connection, there is submitted previous investigation of Special Agent JOHN F. DESMOND of the Boston Field Division as follows. This investigation was conducted at the request of the

Field Division in a letter dated April 8, 1946, which advised that Dr. ABRAHAM WOLFSON, a contact of HARRY WHITE, had contacted an unknown man at Circle 7-8000, room 1928, New York City, and that it had been ascertained that this room was assigned to ABRAHAM WHITE and wife, who were registered there as coming from Boston, Mass. WHITE was connected with Barnstead Still & Sterilizer Company of Boston.

A check of the indices of the Boston Field Office failed to disclose any information on ABRAHAM WHITE.

Confidential Informant T-3 advised that ABRAHAM WHITE resides at 41 Tennyson Road, Wellesley, Mass., and previously lived at 11 Perkins Square, Jamaica Plain, Mass., and at 42 Alexander Road, Newton Highlands, Mass. He moved to Wellesley in May, 1941. This informant further advised that WHITE is Vice President of the Barnstead Still & Sterilizer Company, Inc., 2 Lanesville Terrace, Forest Hills, Mass. He has been associated with this concern for approximately ten years and previously was President of Manhattan Stores, Inc., located at 270 Massachusetts Avenue, Cambridge, Mass.

According to this same informant, WHITE maintains a checking account with the First National Bank of Boston, Jamaica Plain Branch, which usually has a balance in three figures.

The records of the Department of Corporations and Taxation, State House, Boston, Mass., disclosed that the Barnstead Still & Sterilizer Corporation was organized in 1916 for the following purpose:

"To carry on the business as principals or agents of manufacturing, buying, selling, and dealing in water stills, sterilizers, and hospital and manufacturers' supplies and any other business which may seem calculated directly or indirectly to enhance the value of or render profitable any of the company's property or rights or to be conducive of any of the company's objects."

According to a Certificate of Condition filed with the Department of Corporations and Taxation in June, 1945, the company had an authorized capital of 1,000 shares of preferred stock with par value of \$25, and 4,000 authorized shares of common stock with a par value of \$25. Of this amount, 960 shares of the common stock had been issued with a paid-in capital of \$24,000. The balance sheet reflected a surplus of \$124,252.36, and total assets and liabilities of \$195,901.18.

Inquiry at the office of the Town Clerk, Wellesley, Mass., disclosed that ABRAHAM WHITE and his wife, MILLICENT M. WHITE, are listed as registered voters as of January 1, 1945. At that time, WHITE's age was given as 40 and his wife's as 35. Inquiry at the Office of the Town Assessor reflected that the home in which the WHITES reside, at 41 Tennyson Road, is assessed in the name of MILLICENT M. WHITE in the amount of \$9,850.

ERNEST FISHER, Chief of the Wellesley Police Department, and Officer FLEMING of that Department have advised that ABRAHAM WHITE is not known to them, and their records contain no derogatory information concerning him.

JOHN SULLIVAN, mail carrier on the route covering Tennyson Road, advised that he has been delivering mail to the home of ABRAHAM WHITE for a number of years but that he has no information on WHITE or his activities. He stated that WHITE resides with his wife and their three children, and the mail received at this address is very light. Mr. SULLIVAN has never noted anything in the line of out-of-State or foreign correspondence coming to the WHITE address.

Inquiry at Local Board #118, City Hall, Newton Center, Mass., disclosed that ABRAHAM WHITE registered under the Selective Training and Service Act on October 16, 1940, and was assigned Order #1225. In his questionnaire he stated that he was General Manager and Vice President of the Barnstead Still & Sterilizer Company and that his duties consisted of supervising, engineer, production, sales, distribution, purchases, accounting, etc.; and that for his work he received approximately \$135 weekly. He further stated that there were employed under him approximately 30 workers and that the company was engaged in the manufacture of equipment for the Army, Navy, defense plants, and hospitals.

An application for deferment was filed by the employer of ABRAHAM WHITE, stating that he was engaged in essential war work. This statement was signed by ALONZO J. SHADMAN, President, and described the work of the company as follows:

"It manufactures water distilling equipment to provide freshly-distilled water for scientific research, production of pure chemicals and pharmaceuticals, in the preparation of intravenous solutions, blood plasma, penicillin, etc. Direct military uses include conversion of sea water and other contaminated water to drinking water by landing parties, etc., to provide pure distilled water necessary for storage batteries in submarines, tanks, planes, etc.; Army and Navy hospitals, in connection with radar, radio, and aerial photography."

As a result of the foregoing application, ABRAHAM WHITE was classified 2-B by Local Board #113.

The birth of ABRAHAM WHITE on December 28, 1904, at Boston was verified at the Bureau of Vital Statistics, State House, Boston, which record disclosed also that his father was JACOB WHITE, his mother, ESTHER NOVICK, both having been born in Russia. It has also been ascertained by reporting agent that JACOB WHITE was indicated as being a merchant.

It is to be noted that the marriage record of HENRY HYMAN BLOOM to BESSIE WHITE BLOOM reflects the mother of HENRY BLOOM to be ESTHER NOVACK and father as SAMUEL BLOOM, whereas his wife, BESSIE WHITE, furnished her father's name as JACOB WHITE and mother as SARA R. MOGOLOFSKY. Apparently there has been some transposition in the records, and the parents of HENRY HYMAN BLOOM should read SAMUEL BLOOM, father, and SARA R. MOGOLOFSKY, mother, with the parents of BESSIE WHITE as father, JACOB WHITE, and mother, ESTHER NOVACK. In this instance, it was also noted that the parents had been born in Russia:

Reference is made to the report of Special Agent BRENTON S. GORDON dated June 12, 1946, with particular reference to page 4 of this report captioned "HARRY DEXTER WHITE." It should be noted that the Everett City Directory reflected the names of parents to be JACOB and ESTHER WHITE, both born in Russia, that JACOB WHITE was a peddler, and subsequently indicated as a merchant. Although the names of only two sons, NATHAN and SAMUEL, appear in the Everett City Directory, and only HARRY D. WHITE in the subsequent Boston City Directories, there is a strong probability that ABRAHAM WHITE and BESSIE WHITE BLOOM are also members of this same family and that HARRY DEXTER WHITE is the brother of ABRAHAM WHITE and BESSIE WHITE BLOOM.

By letter dated June 14, 1946, the New York Field Division requested the Buffalo Field Office to obtain the names of individuals connected with the Children's Book Shop, 293 Alexander Street, Rochester, New York, and to ascertain background information concerning these individuals.

Observation of the Children's Book & Toy Shop reflected it is located at 293 Alexander Street, Rochester, New York, telephone Stone 4344, and consists of a large two-story frame home converted into a shop which is located in the neighborhood of the more expensive retail shops in Rochester, New York. The Children's Book Shop sells all types of children's toys, books and novelties, and caters particularly to children from the infant stage to eleven years of age. The property is well maintained and in excellent physical condition and is assessed for \$7100.00 at the Assessor's Office of the City of Rochester, in the name of BEATRICE DeLIMA MEYERS.

A review of the records in the County Clerk's Office, Monroe County, Rochester, under the section of Individuals Doing Business Under An Assumed Name, reflected the following information: That on October 24, 1933, the name of the Children's Book Shop, 293 Alexander Street, was registered by MADELINE S HEILBRUNN and BEATRICE DeLIMA MEYERS. The Certificate reflected that MADELINE HEILBRUNN withdrew from the organization on March 11, 1937. On April 26, 1945, another Certificate was filed listing the name as Children's Book Shop, 293 Alexander Street, under the name of BEATRICE DeLIMA MEYERS, 44 Oliver Street, and GERTRUDE K. FLESHER, 85 SanGabriel Drive. On January 23, 1946, a Certificate of Discontinuance of the above assumed name was filed and on January 23, 1946, the name of Children's Book Shop, 293 Alexander Street, was registered under the name of WALTER S. MEYERS as Executor, 44 Oliver Street.

The Children's Book & Toy Shop was founded in 1935 by Mrs. DeLIMA MEYERS and she actively operated the business at that address until February, 1945, at which time Mrs. GERTRUDE FLESHER purchased a half interest in the business and these two individuals operated the business until Mrs. MEYERS'S death October 28, 1945. Shortly thereafter Mr. WALTER S. MEYERS, husband of BEATRICE DeLIMA MEYERS, as Executor of her estate, purchased the half interest of GERTRUDE FLESHER and it has been operated by the estate since that time. The active management of the company today is under the guidance of Mrs. MEYERS'S daughter, namely, RUTH MEYERS PLAKSIN, of 44 Oliver Street. There are three girls employed as clerks in the business, namely, JEAN R. KREUTER, 1539 Highland Avenue, EDITH BAKROW, 28 Audubon, and FRANCES HONE, 68 Meigs Street.

The business has prospered financially and a checking account under the name of Children's Book Shop is maintained with the main office of the Lincoln Rochester Trust Company, maintaining an account of four figures and the following two individuals have authority to write checks on the company: WALTER S. MEYERS and RUTH MEYERS PLAKSIN. As a matter of procedure, however, RUTH PLAKSIN writes the checks. The attorney for the company is one HARRY GOLDMAN, Union Trust Building, Rochester, and the auditor is a Mr. SHAW of F. L. HEUGHES, Lyle Avenue, Rochester.

WALTER S. MEYERS, 44 Oliver Street, Rochester, Monroe 2424, husband of the deceased BEATRICE DeLIMA MEYERS, is the Executor of his late wife's estate and he was born June 10, 1884, Rochester, New York, and has resided for many years at the same address, 44 Oliver Street. He is the Vice-President of the Michael Stern & Company Clothing, 87 Clinton Street, Rochester. Mr. MEYERS and his late wife had two children, namely, RUTH MEYERS PLAKSIN of Rochester, and WALTER DeLIMA MEYERS of Dallas, Texas. Mr. MEYERS registered for Selective Service with Local Board #554, Rochester, New York, and he is described as:

RUTH MEYERS PLAKSIN, 44 Oliver Street, Rochester, telephone Monroe 2424, is presently the active business head of the Children's Book & Toy Shop, Rochester, 293 Alexander Street. She was born October 21, 1912, at Rochester, New York, the daughter of WALTER S. and BEATRICE DeLIMA MEYERS. She married PLAKSIN on August 12, 1934, at Rochester, New York. By this marriage she

A check of the indices of the Buffalo Field Division on RUTH MEYERS PLAKSIN was negative.

MOE PLAKSIN, 44 Oliver Street, the husband of RUTH MEYERS PLAKSIN, was born April 29, 1912, at Rochester, New York, his parents being ABRAHAM and ELIZABETH GOLDBLATT PLAKSIN. He was employed by his father at the Plaksin Liquor & Wine Store, 14 Exchange Street, Rochester, New York, for seven years, and he attended the University of Michigan for one year, and the University of Rochester for two years. MOE PLAKSIN married RUTH MEYERS on August 12, 1934, at Rochester, New York. He registered for Selective Service at Local Draft Board #556, under order number 388 and was inducted in the United States Army January 31, 1944, Army Serial Number 42092524. He attained the rank of Technician 4th Grade in the Signal Corps, being assigned to the 3325th Signal Inf. & Mon. Co., his military specialty being Cryptographic Technician 805. Investigation did not reveal anything detrimental to the reputation of THEO ADAMS.

By letter dated July 18, 1946, the Washington Field Division requested that background information be obtained on one ERNEST J. BROWN, who is employed by the law firm of Kenefick, Cooke, Mitchell, Bass & Letchworth, who was a contact of HERBERT SIMON MARKS, subject in this case.

Pursuant to the above request the following investigation was conducted by Special Agent LEO K. KENNEDY:

The following information concerning BROWN was obtained from the Martindale-Hubbell Legal Directory, and Mr. HARRY J. FOREHEAD, Hearing Commissioner of the New York State Workmen's Compensation Bureau at Buffalo. It is noted that Mr. FOREHEAD and Mr. BROWN were formerly associated with the firm of Kenefick, Cooke, Mitchell, Bass & Letchworth.

ERNEST J. BROWN is forty years of age, having been born in Mississippi. He received a Bachelor of Arts Degree from Princeton University and a Bachelor of Law Degree from Harvard, at which latter place he was a member of the Harvard Law Review and an outstanding student. Following his graduation from Harvard in approximately 1930, he became associated with Kenefick, Cooke, Mitchell, Bass & Letchworth, the largest as well as one of the most reputable legal firms in Buffalo. While with this firm he served in the Contract Department and was generally considered to be very intelligent and capable. At the same time, BROWN was a part-time professor at the University of Buffalo Law School. He was eventually inducted into the Army as a Private, but was soon elevated to Corporal. While serving in the latter capacity, arrangements were made, presumably by PATRICK HODGSON, General Counsel for the Navy Department, to transfer BROWN to O.S.S. It is noted that HODGSON was formerly a member of Kenefick, Cooke, Mitchell, Bass & Letchworth.

and it is believed that other Buffalo attorneys aided in BROWN'S transfer to the latter service. Among these were JOHN LORD O'BRIAN, General Counsel for the War Production Board, and Mr. MANLEY FLEISCHMANN, his assistant. It is noted that Major General WILLIAM J. DONOVAN, head of O.S.S., is a Buffalonian and was undoubtedly acquainted with BROWN.

Following his release from O.S.S., after approximately two years of service, some of which was spent overseas, BROWN returned to Buffalo and became associated with the Buffalo office of JOHN LORD O'BRIAN. Several months ago he was appointed Acting Dean of the University of Buffalo Law School and is still serving in this position. The rumor is, however, that in October of this year BROWN will accept a professorship at Harvard Law School.
