

The unexpected passing of Dr. Samuel Francis has deeply affected us all. This

will be a difficult column to write. I had received a call from Dr. Francis in mid-December. The purpose of his call left me utterly speechless. He asked if I would be interested in assuming editorial responsbility for the Citizens Informer. He explained that he had recently received a grant to write a comprehensive treatise on Conservative Philosophy. In order to devote the time needed to pursue this task, he would not be able to continue the week-to-week logistics editing the Informer. The decision had obviously been difficult; he had put so much into this medium, but given his already grueling personal schedule, and now with a new and extensive project in hand, he really had little choice.

What he proposed was that I would assume his responsibilities as Editor, and he would assume the role of Senior Advisor. We would work in close consultation—he would assist in obtaining material, select from among his weekly columns for inclusion, and would continue to write ar-

ticles for the paper. In short, it would have been a sort of apprenticeship.

I asked if I could think and pray on this with my wife, and he readily agreed.

After Christmas, we spoke again. While I was very enthusiastic about this new opportunity to serve our people, I explained that I had some doubts as to my qualifications—who wouldn't feel underqualified to assume a title held by Sam Francis?

His response revealed a side to him I had never seen. In what I could only describe as a fatherly manner, he first cited the work of some of the younger members of the CofCC, such as Kyle Rogers and Anthony Boor. He then went on—and this is somewhat awkward to relate—that he felt strongly that the next generation had to step up to the plate and begin assuming responsibility for the future of this movement. (With his passing, his words take on a profound significance.)

He reiterated again his wish to remain closely involved with the *Informer*, and urged that I should call him, at work or at home, anytime I needed advisement on the smallest detail—or just needed encouragement. And so I gladly accepted the greatest honor I have ever known.

We scheduled Saturday evening, January 29, to get together and thoroughly discuss what would be involved in this new arrangement—what the procedures were, who to contact and when, scheduling a print run—after which we would formally assume our new, respective positions.

But the meeting never took place.

He called me that morning and said that he was feeling terrible. He thought perhaps he had food poisoning. In fact, he had suffered an aortic aneurysm. He checked into the local hospital and was rushed to surgery. On February 15, while still in intensive care, the Lord called him to rest from his earthly labors.

The profound sense of loss I feel at his departure is shared by the whole movement. We all had hoped to look to him for leadership in the years ahead. I had looked forward to working closely with him on this paper, but must continue absent his guidance, (for which I beg the reader's forebearance as I acclimate to this position.)

Dr. Francis was irreplaceable. His mantle can only be picked by all of us, working together to assure a future for our people. His tireless effortsand great personal sacrifices made on our behalf-were an inspiration and an example we must now follow. His work laid a foundation upon which we must-quickly-build a mass movement for the survival of our civilization. While we grieve the loss of our dear friend, let us honor him by rededicating ourselves to the cause for which he devoted his life, with a firm reliance on Almighty God, and His Son, our Lord Jesus Christ.

Morality Not The Only Target on Monday Night Football

BC Sports last week took careful aim at the "moral issues" that are said to have driven this month's national election and delivered a good swift kick to their dentures on national television.

The main reaction from viewers and the professional "family values" lobby has been to denounce the nudity and clearly implied sex of the now-notorious ad that promoted last week's Monday Night Football game. That's all well and good, but there was more going on in the ad that no one will mention—race.

The ad shows blonde white sexpot Nicolette Sheridan of the steamy "Desperate Housewives" series smooching up to black football star Terrell Owens in the locker room of the Philadelphia Eagles. Then the young lady drops her bath towel

and jumps into Mr. Owens's not-exactly recalcitrant arms.

"Aw, hell," he leers, "the team's going to have to win without me." In the aftermath of the similar reaction to CBS's showing of the Janet Jackson-Justin Timberlake flap during the Super Bowl last February, there can be little doubt the ABC ad was not just a blunder.

It was an intentional act of moral subversion.

It was filmed the Friday before, and in the aftermath of all the jabber about "moral issues" in the election, it ought to be transparent that it was intended as an act of political-cultural subversion as well.

In the CBS incident, Miss Jackson exposed her breast on camera during a performance with Mr. Timberlake. The Federal Communications Commission fined CBS, which broadcast the Super Bowl, the piddling sum of \$550,000—little more than lunch money, of course, for the big networks and hardly a deterrent to similar smacks at good taste in the future.

But taste and morality are by no means the ad's only targets.

Like the Jackson-Timberlake performance, the Owens-Sheridan ad was interracial and brazenly so—if only morals and taste had been the targets, the producers could easily have found white actresses who are less obviously Nordic than the golden-locked Miss Sheridan, but Nordic is what the ad's producers no doubt wanted.

For that matter, if you only wanted to take a swipe at morals and taste, you could find a black woman to rip her towel off or replace Mr. Owens with a famous white athlete (there are still a few).

But that wasn't the point, was it? The point was not just to hurl a pie in the face of morals and good taste but also of white racial and cultural identity. The message of the ad was that white women are eager to have sex with black men, that they should be eager, and that black men should take them up on it.

So far only one voice has mentioned the ad's racial meaning and denounced its "insensitivity" (to blacks)—that of black Indianapolis Colts coach Tony Dungy.

Blacks are permitted to notice race. Whites aren't.

But the ad's message also was that interracial sex is normal and legitimate, a fairly radical concept for both the dominant media as well as its audience.

David Brock, Phony 'Media Watchdog,' Demands I Be Muzzled

"Who is such a sap as to take the word of such a person?" asked journalist Christopher Hitchens about David Brock, another journalist (sort of) who confessed to having penned what he later admitted was a mendacious account of Anita Hill on behalf of the "Republican sleaze machine" (for which he was well paid with royalties and fame). ["The Real David Brock," *The Nation*, May 9, 2002]

Well, lots of people, to judge from the reactions to Brock's latest wallow in self-righteousness, this time directed at me.

Having defected from the right because of his pangs of conscience over his earlier fakeries, Brock has now set himself up as a "media watchdog" who pronounces, to anyone willing to pay attention, on the misdeeds

of real journalists (mainly those on the political right, where Brock and his fans like to purport all evil is located).

Last week, he published an open letter to the president of my syndicate demanding an explanation as to why it distributes my column, with a transparent invitation to stop. The particular column he didn't like was the one of Nov. 26 about the now-infamous ABC Monday Night Football ad starring black football star Terrell Owens and white sexpot Nicolette Sheridan.

What bothered Brock was that I denounced the ad as subverting not only "morals and good taste" but also "white racial and cultural identity" through its deliberate glorification of interracial sex.

"We strongly condemn the clear bigotry of this column," Brock pontificated, the "bigotry" presumably being my dim view of interracial marriage. Well, I'm sorry, but I do take a dim view of it, for the simple reason that I would like my culture to continue. I see nothing wrong with that. As a matter of fact, I'd like to know why Brock thinks there is something wrong with it. Nor am I the only one to think so.

In recent years, any number of prominent Jewish spokesmen have expressed their own concerns about Jewish intermarriage with non-Jews. One in particular is Chief Rabbi Jonathan Sacks of Great Britain, who writes:

"The Jewish people, having survived for thousands of years in the most adverse circumstances, including the Holocaust, is today threatened by intermarriage and assimilation. Jewish communities throughout the diaspora are experiencing demographic decline. Why has this happened, and can anything be done to reverse the trend?"

Nor is the chief rabbi alone. A few years ago, neo-conservative Elliott Abrams, then president of the Ethics and Public Policy Center in Washington and now on the National Security Council staff, wrote a book, Faith or Fear, in which he described rising rates of Jewish intermarriage to non-Jews as a "demographic disaster."

I'm not Jewish, but these gentlemen are right, and they have every reason to worry about what Harvard law professor Alan Dershowitz calls "the vanishing American Jew"—a result of intermarriage with non-Jews.

Nevertheless, for decades, interracial couples of different sexes have been sneaked into advertising, movies and television series, and almost certainly not because of popular demand from either race. The Owens-Sheridan match is only the most notorious to date.

In the minds of those who produced the ad, race is at least as important as the moral and aesthetic norms their ad subverts.

To them, the race as well as the religion, the morality, and the culture of the host society are all equally hostile and oppressive forces that need to be discredited, debunked and destroyed.

White Pride is "Offensive" and **Therefore "Scandalous"**

So Rules US Department of Commerce Office

San Bruno, CA. February 7, 2005-The US Department of Commerce (USPTO) has made a final ruling on an application for a Trademark that the words White Pride, are "offensive and therefore scandalous"; the application #78/368298 was filed by the Honorable Justin B. Moritz. His appeal was rejected.

Commerce Dept. Attorney Barbara Rutland, (ECom105@uspto. gov or 202-482-2000,) based her ruling on "a Lexis/Nexis datebase and a search of the Internet using the search engine www.google. com, [and found] the WHITE PRIDE element of the proposed mark is considered offensive and therefore scandalous."

Apparently Ms. Rutland is unaware that the White House Office of Management and Budget has racially classified almost 70 percent of US citizens as being "white." That White House office also racially classifies other US citizens as being black, Asian/Pacific Islander, Hispanic and Native Americans.

According to the USPTO's own website they have approved many racially identified Trademarks, such as Black Supremacy, African Pride, Asian Pride, Jewish Pride, Kwanzaa Pride, Mexican Pride and many more.

It is certainly shocking to be told that based on a Lexis/Nexis search, and the contents therein, that almost 70 percent of US citizen should be ashamed of having pride as members of the white race when they have been so classified by the White House Office of Management and Budget.

The European/American Issues Forum strongly requests that this decision be immediately reversed and a formal written apology be given to the Honorable Mr. Justin J. Moritz and all European American white citizens of the United States of America.

Ukrainian Christians Played an Important Role in the Orange Revolution and the December 26 Election

n November 21, 2004, a runoff election was held in Ukraine to elect a new President, who would replace current President Leonid Kuchma. The two candidates were Viktor Yanukovych, Governor of the Donetsk region, a labor leader and the hand picked successor to Kuchma and the opposition candidate, Viktor Yushchenko. The Ukraine Election Commission announced the results of the balloting by declaring Mr. Yanukovych the winner with 49.46 percent of the vote compared to 46.61 percent for Mr. Yushchenko. Immediately large protests were launched by Yushchenko supporters claiming gross election fraud. Within 24 hours of the officially announced election count about 11,000 specific complaints charging voter fraud were filed with the regional courts.

Among the charges was one made by a journalist working at polling station 73 in a Kiev suburb, who witnessed ballot papers destroyed with acid poured into 6 ballot boxes, causing the ballots to evaporate. In another fraud recorded by observers from the Organization for Security and Cooperation in Europe, voters were given pens filled with ink that quickly disappeared leaving ballots unmarked and unsigned. Yet another trick was for a large number of Yanukovych supporters suddenly to converge on a polling place with clubs and start beating voters over the heads and then seizing the ballots from the stunned poll watchers, and taking them to cars and then speeding away. At other polling stations, a smaller group of armed men would enter, seize all ballots at gun point, run to getaway cars and escape. Yanukovych denies rigging the vote and claims that a "small clique" of his opponents were staging some of these incidents to divide and confuse voters. Issues very important to many Ukrainians were at stake. Ukraine has been an independent country since 1991. President Vladimir Putin of Russia would very much like for Ukraine to once again become a part

of Russia, as it had been during the Soviet Union, and indeed from 1785. He even came to Ukraine, during the campaign and promised to give all Ukrainians dual Russian citizenship. He invited Ukraine to enter a Common Market with Russia, Belarus and Kazakhstan. He also promised to give Ukraine very inexpensive oil and gas in return for an important pipeline through Ukraine to Western Europe. This plan was supported by President Leonid Kushma and his hand picked successor Yanukovych.

that he was poisoned, but that he will recover and look like his old self after several months.

These issues were of great importance to Protestant Christians. As soon as freedom of religion was allowed in Ukraine, beginning about 1985, a great revival broke out, especially among the Baptists and other Bible believing Protestants. Churches were planted, tens of thousands of people were converted to a genuine faith in Christ. The Baptists now number about 200,000. There are probably another 150,000 Christians in Pentecostal, Independent, and Mennonite assemblies. In the far west near the Hungarian and Romanian border, there are a number of Reformed and Lutheran churches, which have been there for more than two centuries at least. All of these have grown under the new freedoms, which were granted when Ukraine became independent.

demonstrators could stay for a long time, and have a place to sleep and stay warm from the snow and subfreezing temperatures. The Yushchenko supporters started wearing organ scarves, sweaters and caps. In a very few days, they began waving orange flags. The media began calling the demonstrators "the Orange Revolution." Nobody knows why the color orange was chosen." said Pavlo Vasiv, a veterinary student from western Ukraine. "It's a pretty color, and everyone seems to like it." Vasiv said that he was staving until Yushchenko becomes President."

The whole purpose of the demonstration was to demand a new election commission and new elections, since the November 21st election was so fraudulent that it had to be ruled invalid.

Christians, mostly Baptists, were among the demonstrators almost from the beginning.

The Rev. Sunday Adelaja, pastor of a very large Pentecostal Church in Kiev, explained that his church had been actively involved in caring for demonstrators who were braving the cold and snow. Every night his church took in 1,000 people to provide food, clothing, medical attention and a warm bed. After those individuals left the next morning to continue their vigils, another 1,000 rotated in the same evening. This continued for more than two weeks. He said an Army General told him that his secret agents who were infiltrating the crowds reported back to headquarters that there were many prayer meetings. They reported that Christians so influenced the crowds that no shops had been looted, no items had been stolen. No one was getting drunk or trying to start fights, all things which are unheard of among any crowd to gather in an Eastern European nation.

Viktor Yushchenko warned that such a plan would dilute Ukraine's independence, and ultimately, Ukraine would be integrated into Russia again.

Another campaign issue was the fact that Yushchenko had been badly poisoned, during the run up to the November 21 vote. His body was weakened and his quite young looking face became pock marked and there were some scars. He claims that he was poisoned by Kushma, Yushchenko and their supporters at a dinner at which the two candidates had a debate. Doctors have indeed proven

Soon a large tent city came into being in Kiev practically overnight so that the In a few days, Roman and Greek Catholics joined in the demonstrations as did a number of Orthodox leaders, including the Patriarch of the Ukrainian Orthodox Church.

Mykhailo Filaret, who openly endorsed Yushchenko, said that while President Putin had given a great deal of religious freedom to Catholics

and Orthodox congregations in Russia, he feared that the brutal repressions under the old Communist Soviet Union could return. He believed that Catholics and Orthodox believers would be better off in an independent Ukraine.

Of course, Bi-

ble-believing Protestants could not have any joint services with Catholics or Orthodox, because of the great theological differences, but they felt they could demonstrate with them for an independent Ukraine where there would be complete freedom of religion. Without Christian influence, the demonstrators might have become a thuggish mob. The Christians definitely influenced the ultimate election of Yushchenko, whom many Protestant pastors said is "influenced by God and the Bible. He is serious about his faith."

In the meantime, President Putin injected himself directly into the election crisis in the former Soviet republic. He attacked the opposition's demand for a new presidential runoff and cautioned the West getting involved in an area where Russia had traditional interests at stake.

But the West did become involved. Lech Walesa, hero of Poland's liberation and the founder of the Solidarity movement in his country, told a mass meeting of Yushchenko's supporters in Kiev, "Poland supports you, but you must do this yourself. I hope that Ukraine can avoid the mistakes that Poland made, such as the imposition of martial law."

Quickly, President George Bush said that there should be new elections in Ukraine. He then sent Senator Richard Lugar, (R-Indiana) to Berlin to meet with German Chancellor Gerhard Schroder, saying that Ukraine was a good place for the two countries to work together. Germany then called for a peaceful solution and several other NATO countries joined Germany in this endeavor, I have read in news reports that President Bush actually gave \$65 million dollars in U S funds to pro-Yushchenko organizations well before the November 21 vote. Of course, there is another side. Ukraine has traditionally been a part of Russia. Most Russians believe that Kiev is the cradle of early Russian civilization. They believe that NATO is trying to surround them. On the other hand, NATO does not want to harm

By November 22, at least 250,000 demonstrators took to the streets of Kiev to demand new elections. Russia. Russia is rapidly becoming underpopulated and needs all of its 170 million people to defend its borders, especially from Chinese encroachment.

I believe in this case, to help our fellow Protestant Christians, if for no other reason, I am willing to support the Orange Revo-

lution, and President George Bush in Ukraine. However, I am unwilling to believe that it is the duty of the American people to impose "American style democracy" on the other nations of the world. I still believe it is wrong to start an unjust war, in Iraq, for example. That's why the Iraqis are fighting back. Unjust wars, as Christians have believed from the time of Augustine, are wrong.

There are risks in Ukraine. Russia is still a formidable nuclear power. However, if Ukraine is forced to become part of Russia, the persecution of Christians will sooner or later begin again.

For now the matter is settled. On December 26, Viktor Yushchenko was declared the winner of the new election. The vote must still be officially declared, and he won by only three percentage points, but it was a very free and fair election, monitored by over 1200 outside observers, and well policed by Ukrainians of all parties themselves. As soon as the results were announced, over 5,000 supporters gathered in the main square in Kiev, singing, cheering, shouting slogans, and waving orange flags, their hero's emblematic color. Fire works were set off, and then the celebrators clasped hands and danced to traditional Ukrainian music.

Earlier Yushchenko had declared to the journalists that Ukraine had opened a new era, that would bring about new freedoms, including freedom of religion.

BLACK MONDAY AFTER 50 YEARS

From 1776 til 1954, 178 years since the birth of the USA, the people and the States had the right and the duty to educate their children without interference from the Federal government. This right along with others was guaranteed by the Tenth Amendment to our Federal Constitution.







In the past two months, since the site began its redesign, daily traffic has already doubled. Users can request a free copy of the *Citizens Informer* online, and the Council is getting new contacts daily from all over the country as well as Canada. Users also have the ability to join, renew, subscribe, or donate money via credit card with secure online order forms.

The most important feature is the interactive online calendar. Users can see meeting and event dates for various chapters. This section of the webpage has the greatest potential to attract new members. Diligent participation from all the chapters is needed. Each chapter has the ability to list their meeting and activity dates on the calendar. The calendar has an automated form that allows each chapter to post notices to the calendar themselves using a username and password. Those who post meeting dates do not have to give out sensitive details. All that is needed is to list the city and state, and way for people to contact the chapter or individual such as an e-mail address or telephone number. The more meetings and events we have posted on the calendar, the better the CofCC looks to people visiting the site. Also, many people will be more likely to get interested if there is a meeting in their area. Other users will check the website periodically to view the calendar, and may get involved at a future date once a meeting is held in their area.

It cannot be stressed enough how important it is for every chapter to have their meeting dates posted. Chapters will get new contacts, new people attending chapter meetings, and new members will join the CofCC. Supreme Court Ends Segregation—AGAIN

The U.S. Supreme Court has struck again. In *Johnson v. California*, decided on Feb. 23, the Court once more intruded into the affairs of a sovereign State over matters that were in no way a Federal concern—and whites will pay the price.

The California prison system has followed a practice of segregating prisoners for an evaluation period of 60 days, after which they would be introduced into the general population. This was a simple safety measure.

As Dr. Sam Francis pointed out in his VDare.com column of March 8, 2004, even a liberal group, Human Rights Watch, acknowledges that prison rapes are overwhelmingly perpetrated by blacks against whites. (See also American Renaissance, April 2002, at www.amren.com.) Nevertheless, the Court's majority, with Scalia and Thomas dissenting, found the practice in violation of "equal protection." The majority evidently failed to consider that for whites to be raped and beaten upon entering prison "may affect their hearts and minds in a way unlikely ever to be undone."

Truth or Consequences or Truth and Consequences?


"TRUTH OR CONSEQUENCES" implies that there will be severe consequences if a person or group of people do not tell the truth. On the other hand, "Truth and Consequences" would be what would happen if politicians were to tell the truth. Virtually all of them would be defeated.

When Congress was trying to remove Bill Clinton from office on charges that he lied under oath (nothing was said about the many lies that he told when he wasn't under oath), I made the remark that if every politician who lied was removed from office, we would have no government. The Democrats are accusing President Bush of lying--especially about Iraq. This is a case of the pot (no pun intended) calling the kettle black.

To look at some Democratic "truths" let's go back in memory to the administration of Woodrow Wilson who won a second term in 1916 with the slogan "He kept us out of war." Then, less than a month after the start of his second term, he asked Congress for a declaration of war against Germany.

His main reason for war was German submarine warfare. However, the flaw in this was that the submarine warfare that most aroused the American public happened in May of 1915--virtually two years before the declaration of war.

The event was the sinking of the British "passenger liner" LUSITANIA. Unfortunately, for the passengers on board, it was also carrying munitions from the U.S. to England. The German government placed full-page ads in the major New York City newspapers the day before the ship sailed, warning people not to travel on it.

"The Colonel," A.K.A. Fred C. Jennings was born in 1926 in Winters, TX, a small farming community.

"The Colonel" graduated from Winters High School and attended Abilene Christian College for one year. Then he attended S.E. MO College until 1949. While there, he was Associate Editor of the college newspaper, *The Capaha Arrow*.

In 1950 he entered the military and served in the Army's 3^{rd} Infantry Division in Korea until an accident sent him home and discharged.

In 1952 he went to work as an inspector for McDonnell Aircraft from which he retired in 1990.

He is a strong believer in States' Rights. He voted for Gov. Wallace for President in 1968 and joined the Citizens Council in 1969. He is a charter member of the Council of Conservative Citizens.

World War II against Germany. He violated the Neutrality Act which Congress had passed to forbid the selling of war materials to any of the combatants in World War II by using "Lend Lease" to supply war materials to England and traded destroyers for English bases in the West Indies which the British could not have defended if they had been attacked.

Our ships carried war material to England and Russia in spite of the Neutrality Act, which made them military targets, which the Germany submarines

(U-boats) attacked. Naturally, our ships shot back (merchant ships had gun crews aboard) when possible, but Germany was smart enough to know that all out war with the U.S. would lead to certain defeat.

After Roosevelt came Harry S. Truman. He didn't lie to get us into war. He just ordered American troops into combat (without any action by Congress) to defend a country whose soldiers were not very eager to defend it. After General MacArthur told him (Truman) that there was no possibility that China would come into the war, he said that the troops would be home by Christmas (1950). There are still 35,000 American troops in South Korea.

Then there was J.F.K. and the Bay of Pigs.

The granddaddy of liars, L.B.J., reported to Congress in August 1964 that North Vietnamese torpedo boats had attacked our ships in the Tonkin Gulf. As a result, Congress enacted the Tonkin Gulf Resolution, which, although not a declaration of war, did authorize the president to carry the war into North Vietnam. It was later revealed that the Tonkin Gulf attack never took place.

L.B.J. was a Congressman and a Lieutenant Commander in the U.S. Navy Reserves. He went on active duty in December 1941 and went on an observation mission to Australia and New Guinea. The plane on which he was an observing passenger was attacked by the Japanese over New Guinea but it escaped. For this mission, he received the Silver Star and an order from Franklin Roosevelt to come home and resume his congressional duties. He resigned his commission in July 1942.

Franklin Roosevelt was under-secretary of the Navy in the Wilson administration. In 1932, he was elected the first Democratic president since Wilson. He was undoubtedly a champion

con man. He was elected President four times but died less than three months into his fourth term.

He tried for over two years to get the U.S. into


He became Editor of the *Citizens Informer* in 1971 and did that job until 1999 when heart problems sidelined him.





Guest Worker Program Based on Deadly Equivalency

George W. Bush had been re-elected as President less than a month before he revived one of his most controversial schemes, a guest worker program, which would grant a de facto amnesty to illegal aliens in the U.S. and, worse yet, allow unlimited entry to aliens entering the country as employees. The last time he proposed this idea the public outcry against it was so great that it was soon shelved. Again, we need to make our feelings known on this issue.

Implicit in the Bush guest worker program are some presumed equivalencies that are a kind of Marxism in reverse. Basically, Bush wants us to believe that working people are equivalent to the labor which they sell, which, most important of all, is just another commodity. Just as there is to be a free trade in commodities, there is to be a free trade in labor which is assumed to be just another commodity.

These are deadly equivalencies which, if taken as a basis for public policy, will bring to an end both the American nation and the American middle class. Americans know that their nation is more than just a gathering place for producers and consumers from anywhere and everywhere. They also know that America's workers will be reduced to lower and lower standards of living if the U.S. labor market is flooded by being opened to a limitless supply of cheap labor from south of the border.

Although capitalism is a more productive economic system than is socialism, it (like all human systems) has its flaws. The great engine of capitalist productivity seems to turn over and run at its highest efficiency only if it is fueled with injections of cheap labor. The cheap labor may be generated by slavery or mass unemployment or (as at present) mass immigration, but it is a favored way to widen profit margins. The alternative, of course, is to increase the productivity of labor, but this is less appealing to those who seek to get rich quickly.

Karl Marx actually favored free trade in all commodities, including labor, because it would hasten the coming crisis of capitalism. The last paragraph of Marx's speech on free trade delivered in Brussels in 1848 is as follows: ". . . in general, the protective system of our day is conservative, while the free trade system is destructive. It breaks up old nationalities and pushes the antagonism of the proletariat and the bourgeoisie to the extreme point. In a word, the free trade system hastens the social revolution. It is in this revolutionary sense alone. gentlemen, that I vote in favour of free trade."

George W. Bush (and the advisors behind him) are practicing class war in reverse, taking the role of the bourgeoisie against the proletarians. Reverse Marxism is just as destructive as Marxism itself. A nation without a large middle class lacks both stability and substance. American national identity and the livelihoods of American employees should not be cast overboard to lighten the load of labor costs and buoy up profits. An America without middle Americans, in the ethnic, cultural and economic sense of the term, will run aground and smash to bits in short order.

Mexico is now threatening to move their complaints against the measure to "international tribunals."

eanwhile, other States are **IVI** looking to follow Arizona's lead. The Virginia Legislature passed a measure to deny illegal aliens access to State and local benefits. A bill has been introduced in the Oklahoma Legislature which would permit lawful employees to take legal action against employers who hire illegal aliens. While a similar measure is reportedly being considerd in Arkansas, the State House has taken a step backward, passing a bill allowing illegal aliens who graduate from high school to qualify for in-State tuition. The measure was introduced by Rep. Joyce Elliott, black representative of Little Rock, (equating the illegal immigrant question to the "civil rights" movement,) and was supported by Gov. Mike Huckabee, who likened the issue to the segregation controversy in 1957. (See page 23.)

Immigration News

Illegal immigration continues to strain already overloaded State services across the Republic. A study by the Federation for American Immigration Reform (*www.fairus.org*) reveals that California taxpayers are now spending \$7.7 billion per year on education for illegal immigrants' children (including their offspring born in the U.S.), \$1.4 billion per year for health care, and \$1.4 billion on illegal immigrants currently incarcerated.

New Jersey hospitals are expected to lose \$200 million dollars this year alone providing uncompensated services to illegal aliens, and the figure is only expected to get worse.

Enforcement efforts in numerous States continue to be hampered by logistical hurdles, exacerbated mostly by lack of will. Texas currently leads the States in no-shows by illegals who have been released *on their own recognizance*. (The number of criminals so released went from 5,700 in While the respective States are facing an escalating invasion—and a few fighting back on their own—the President of the United States doggedly continues to push his "guest worker program" (i.e. amnesty) for millions of criminal aliens.

A much-ballyhooed provision in the intelligence bill signed into law in December would purportedly have added 2,000 Border Agents per year for the next 5 years.

It hardly mattered, thanks to a littlenoticed escape clause: "subject to available appropriations." And—wouldn't you know it?—the budget proposed by the Bush administration *fails to request the needed appropriation.*

In summary, President Bush continues to flout the will of 80% of the American people, and to spurn his obligation under the Constitution to "take Care that the Laws be faithfully executed." (Art. II, Sect. 3) An American citizen, James W. Gilchrist, is organizing The Minuteman Project, billed as "Americans doing the jobs Congress won't do." Their web site, *www.minutemanproject.com*, claims that nearly 700 Americans from 49 States have already signed up. The group will aid the U.S. Border Patrol in surveillance of border crossings.

Mexican Foreign Minister, Luis Ernesto Derbez has vowed to fight the Minuteman Project. "We are going to attack by all legal means," he said, adding that he would discuss with Secretary of State Condoleeza Rice during their March 10 meeting.

(The MS-13 gang, mentioned above, has threatened an *armed con-frontation* with the Minuteman group.)

Mexico's Foreign Ministry has already drawn the wrath of patriotic American lawmakers for circulating a *comic book* with transparent instructions on how to sneak into the U.S.

2002 to over 30,000 last year.)

The problem of criminal alien gangs continues to escalate from coast to coast. The most dangerous of these is "Mara Salvatrucha" (aka "MS-13"), implicated in numerous crimes, including murders of police officers, gang rapes, mutilations by machetes, drug trafficking and human smuggling.

Boston police are alarmed at evidence that this gang is now cooperating with militant Mohammedan groups *to smuggle terrorists into the U.S.* In the Congress, the House of Representatives is now considering a bill to deny U.S. citizenship to children born to illegal immigrants. Please urge your Representative to support the Citizenship Reform Act of 2005.

The House recently passed Rep. James Sensenbrenner's REAL ID Act, which imposes Federal standards on drivers licenses. But Bryanna Bevens, writing in *VDare.com*, notes that this bill could actually *hasten* the day that a current illegal is granted a license. One act of enforcement, by the Immigrations and Customs Enforcement (ICE) did not escape notice. In December, the ICE apprehended smugglers who were attempting to bring parrots into the U.S. illegally, prompting Congressman Tom Tancredo to observe that, "Apparently there are no jobs available that American parrots won't do."

We hear that Rep. Tancredo has recently made an exploratory visit to New Hampshire. We can only hope!

Amnesty: It Didn't Work Then & It Won't Work Now!

Nine Amnesty Bills in Congress

■ There are nine bills currently in Congress vying to be amnesty no. eight. Some have amnesty as the main goal, while others have it as a hidden agenda. Each bill is listed below with complete details on its amnesty plan:

• H.R. 2899/S. 1461, Border Security and Immigration Improvement Act This bill would create a legalization process for almost all illegal aliens who will then be eligible for green cards after 6 years. Under the provisions of S. 1461/H.R. 2899, an illegal alien would receive a 3-year H-4B visa. At the end of 3 years, the alien can adjust to an H-4A "guestworker" visa, valid for 3 years. Following this second 3-year period (a total of 6 years), the alien can self-petition for a green card. However, an employer can petition for a green card for any H-4A visa holder after the first three years.

• H.R. 3142/S. 1645, Agricultural Job Opportunity, Benefits, and Security Act of 2003 H.R. 3142 would create a guestworker program that leads to amnesty for certain agricultural workers. The potential recipients of the amnesty will be required to prove 100 days of agricultural employment in the 18-month period that ended Aug. 31, 2003. Then, prior to receiving amnesty, workers would have to show 360 days of additional farm work over the next six years.

• S. 1387, Border Security and Immigration Reform Act of 2003 S. 1387 would create a temporary guest-worker program for illegal aliens with an amnesty-on-installment program. After working in the U.S. for three years, the illegal alien guestworkers would be required to return to their home country in order to apply for a green card. At that point the alien would, in most cases, be rewarded with a green card and an amnesty from the usual penalty of not being able to return to the U.S. for 10 years after illegally being in the U.S.

rary visas are renewable and "willing workers" and their families will be able to adjust to permanent resident status under the provisions of S. 2010. S. 2010 would bring in an unlimited number of new immigrants by removing immediate family of non-citizen immigrants from under the current numerical cap. Furthermore, S. 2010 would grant an amnesty to millions of illegal aliens. Illegal aliens who lived in the U.S. for at least five years before January 2004 can apply for amnesty if they have been employed for at least three of those five years. At least six million illegal aliens are estimated to be eligible for this amnesty.

• S. 1545, Development, Relief, and Education for Alien Minors Act of 2003 and H.R. 1684, Student Adjustment Act of 2003 A bill to grant in-state college tuition rates and amnesty to illegal aliens under the age of 21 who have been physically present in the country for five years and are in 7th grade or above.

• H.R. 3271, Earned Legalization and Family Unification Act of 2003 A bill to grant amnesty to an estimated 6.5 million illegal aliens who have lived continuously in the U.S. for five years prior to enactment of the bill. In addition, H.R. 3271 would eliminate the annual cap on family-based legal immigration, increasing chain migration by about 250,000 a year.

• H.R. 1300, Central American Security Act A bill to extend the massive NACARA amnesty for Nicaraguans and Cubans to up to 2.3 million illegal aliens from El Salvador, Guatemala, and Honduras.

• H.R. 2843, Andean Adjustment Act of 2003 H.R. 2843 would reward illegal aliens from Peru and Colombia with amnesty, provided they have been in the U.S. since December 31, 1999.

Congress has passed 7 amnesties for illegal aliens, starting in 1986.

1.	Immigration and Reform Control Act (IRCA) Amnesty, 1986: A blanket amnesty for some 2.7 million illegal aliens, which was supposed to be the LAST amnesty.
2.	Section 245(i) Amnesty, 1994: A temporary rolling amnesty for 578,000 illegal aliens.
3.	Section 245(i) Extension Amnesty, 1997: An extension of the rolling amnesty created in 1994.
4.	Nicaraguan Adjustment and Central American Relief Act (NACARA) Amnesty, 1997: An amnesty for close to one million illegal aliens from Central America.
5.	Haitian Refugee Immigration Fairness Act Am- nesty (HRIFA), 1998: An amnesty for 125,000 illegal aliens from Haiti.
6.	Late Amnesty, 2000: An amnesty for some il- legal aliens who claim they should have been amnestied under the 1986 IRCA amnesty, an estimated 400,000 illegal aliens.
7.	LIFE Act Amnesty, 2000: A reinstatement of the rolling Section 245(i) amnesty, an estimated 900,000 illegal aliens.

SOCIAL SECURITY IN RACIAL CRISIS

Despite what some nay-sayers think the Social Security system will indeed be in danger of ending by 2042. Projections by the census bureau prove this. Currently, the country is about two-thirds white and one-third nonwhite. At the same time whites make up about 85% of those drawing Social Security.

By 2042, nonwhites will make up the majority of the population and seize political control of the government (with support from white liberals). Whites will still comprise perhaps 75% of those drawing Social Security payments, due to the greater longevity of whites and the postwar baby boom generation still surviving in large numbers.

With this being the case the Social Security system will simply be repealed by the government around that time. A non-white President and Congress will have no interest whatever in maintaining a pension system that primarily benefits the white population, and will do away with it. According to accounts given to the *Clayton County News Daily*, the 27 discharged employees were "herded into a jail cell" and then were stripped of all property belonging to the county. Afterwards they were taken out under *armed guard*. The Associated Press added that *snipers stood guard on the roof*. They were then escorted to a police van.

One of those fired was a 38-year veteran. Four were among the highest ranking officers. The new sheriff referred to the firings as a "reorganization" and explained to the Atlanta Journal-Constitution that they would be replaced by blacks. Fortunately, Superior Court Chief Judge Stephen E. Boswell intervened and granted a restraining order, noting that the employees were apparently terminated "without cause." But this may not be the end of these employees' fight, as it was still unclear whether they are covered under the civil service law. That remains to be determined in subsequent hearing.

Of course, we need not mention what the reaction would have been if the respective racial roles were reversed. This is what the other side means by "equality."

AIDS, Blacks, and Immigration

A report from the Federal Centers for Disease Control and Prevention indicates that HIV infection has at least doubled among American blacks in the past ten years. Currently, one out of every *fifty* blacks is a carrier—*ten times* the white rate.

One of the explanations proferred for this disparity is, of course, white racism. But some black health professionals regard the obsession over white conspiracy theories among blacks as distracting from preventative behavior.

In Africa, over 25 million persons now carry the virus according to the BBC, and the UN estimates that 90 million will be infected within the next two decades. The World Health Organization estimates that 600 die of AIDS related causes every day in South Africa alone.

The UN estimates that it would require 10 billion dollars annually to fight AIDS in Africa, and has insisted that the United States ought to cover at least one-fourth of this sum. Other world leaders (such as rock star Bono) have pushed for the United States to spend more money on Africa.

One way or another, the United States are going to have to address certain realities, as we learn from a Feb 2 article in the *New York Times* that now, for the first time in history, more blacks are emigrating to America than were brought over during the slave trade.

Smithsonian taps known Communist to Honor M.L. King

On January 13, "civil rights" leader Jack O'Dell led an event honoring M.L. King at the Anacostia Museum. Mr. O'Dell took occasion to assert that Mr. King would have supported sodomite "marriage." Correta Scott King, Mr. King's widow, has also invoked her late husband in support of such unions, with the backing of her son, M.L. King III.

But it was Mr. O'Dell's communist credentials that raised eyebrows. A former aide to Mr. King, Mr. O'Dell was dismissed from this role at the urging of President Kennedy, who noted that the FBI had tagged Mr. O'Dell as the no. 5 man in the Communist Party, USA.

Mr. O'Dell continued to defend communism, and in 1985, according to the *Washington Times* (Jan 14), described U.S. opposition to the Soviet Union as "an integral part of the bellief system of racism and Western national chauvinism."

For our part, we applaud the Smithsonian's choice of Mr. O'Dell as entirely appropriate in honoring a presumptive fellow-traveler. A known plagiarist might have fit the bill with equal propriety, perhaps. (We note however that Alex Haley is deceased.)

"Conservative" Black Columnist Paid Off by Bush Administration

Nationally syndicated columnist Armstrong Williams reportedly was discretely paid over \$240,000 by the Bush Administration as a sort of bribe to chime in support of Mr. Bush's "No Child Left Behind" program to the black community. (A program that represents the largest increase in spending since the Federal intrusion into education began in 1954.)

SPLC Denounces the Washington Times

Speaking of the *Times*, they are now under fire from the Southern Poverty Law Center for publishing the work of "extremists" on race and other topics. We recall that the *Times* fired the best columnist they ever had—Dr. Sam Francis—for comments made at the first American Renaissance conference in 1994—comments that seem to pale in comparison to those now alleged by the SPLC.

Perhaps there's a lesson here: You can't placate the hard Left; you can only lose good men.

He understood that only good Southerners can be good Americans.

As I used to hear people remark in the 1950's and 1960's, "show me a bad Southerner and I'll show you a bad American."

Beyond that, Sam was a good European.

Sam did not allow his attachment to what was particular in the South to blind him to the realities which our larger people faced and still face in the closing decades of the 1900s and the opening years of the new millenium.

Too many White people want to fight other Whites over things which—-while they do matter—are not what is crucial. Southerners against Northerners/Celts vs. Anglo-Saxons/Catholics vs. Protestants.

Sam understood that the South and America are relatively young shoots off an old tree in Europe.

He could be an American without falling for the liberal propaganda line that somehow Americans and their cousins who stayed in Europe are enemies, that America is in some way something new and necessarily anti-European. In short, Sam understood that our race and its civilization are under attack and in danger of extinction-not merely in the South, but also in the country, and not merely in this hemisphere, but also in Europe and around the globe.

Finally, while Sam's conservatism was rooted in the real rather than the product of abstract principles, Sam understood the importance of principles and was loyal to what conservatives believe and are supposed to believe.

It is certainly a cause for pessimism to see and reflect how few other conservatives have remained loyal to our principles. Unlike such pseudo-conservatives, Sam never lost sight of what our principles as well as common sense teach us:

1. That you cannot preserve liberty at home by waging war abroad.

2. That you cannot cut taxes and wage wars because wars are expensive

Sam Francis understood that our race and its civilization are under attack and in danger of extinction-not merely in the South, but also in the country, and not merely in this hemisphere, but also in Europe and around the globe.

Carnegie Endowment for International Peace who said of President Bush's Inaugural Address, that the President's "goals are now the antithesis of conservatism. They are revolutionary." In concluding that same column Sam remarked that Bush had confirmed once and for all that the administration's neo-conservatism is "fundamentally indistinguishable from liberalism."

Sam paid a huge price for his virtues.

Because of his refusal to join with the phony conservatives in lying about the race issue, he was fired from his position as editorial page editor of the Washington Times. The phonies implacably pursued him after that firing, waging a campaign to pressure newspapers into discontinuing his columns, a campaign for censorship and thought control one would normally associate with the Marxist left. (But then, as Sam would point out, distinctions between the phony conservatives and the Marxists are getting as blurred as those between such conservatives and the liberals!)

Sam was willing to pay that price. This is why we honor him and mourn his death.

And if our people do survive, surely the name of Dr. Samuel T. Francis will be held ever in honor and reverence.

I will never read Sir Walter Scott's Lay of the Last Minstrel without thinking of Sam - and of the few others like him, the good, the loyal, the brave.

"Breathes there a man with soul so dead.

Who never to himself hath said,

'This is my own, my native land!

Whose heart hath ne'er within him burned,

As home his footsteps he hath turned From wandering on a foreign strand!"

As Sir Walter Scott is saying, a psychologically healthy man connects. He connects with his birthplace, his childhood home, his family, his friends, his people, his country his race.

Today, however, most Ameicans are psychologically unhealthy. They do not connect. Nor do most so-called conservatives really connect. They don't really connect with their people and certainly not with their race.

Indeed, the liberal establishment dins it into the heads of everyone from infancy that the worst thing any White can do is to connect. A sociopath is someone who does not connect and our society is full of sociopaths.

The first lines of Sir Walter Scott's poem are widely familiar. The final lines are not so often remembered but they speak eloquently of the ultimate fate in store for the sociopathic neoconservatives (and liberals too) who are too sophisticated (or so they think) to care about their race.

In speaking of those who have such dead souls as never to say, "This is my own my native land" (or, in the case of the larger racial issue, "This is my own, my own people"), Scott says:

"If such there breathe, go, mark him well!

For him no minstrel raptures swell! High though his titles, proud though his name,

Boundless his wealth as wish can claim;

Despite those titles, power and pelf, The wretch, concentrated all in self, Living, shall forfeit fair renown,

And, doubly dying, shall go down, To the vile dust, from whence he

sprung, Unwept, unhonoured and unsung!"

Unlike such sociopaths, Sam connected. He sacrificed himself, his comfort, his financial security and perhaps even his health for his people and his race.

He died poor in material things but rich in honor.

Our people at large may not know who has died. They may not know that one of the few who champion them and their survival has been taken away.

However, we in the Council know.

Farewell, Prophet of the Soil

r. Samuel Francis, described by both our friends and our detractors as the "Philosopher King" of us all, passed away on the night of February 15, 2005, at the age of 57. He passed of complications due to heart surgery necessitated by an aortic aneurysm.

Dr. Francis is survived by a sister, one nephew and two great-nephews.

Dr. Francis came into this world in 1947, in a place once gleefully referred to as "The Dynamo of Dixie," Chattanooga, Tennessee. Chattanooga was once referred to with that moniker because, for a long time, it was, in contrast with most of the South, a center of industry, education, intellectualism and enlightenment, and it was all of that without being snobbish or condescending. One would only expect someone with the wisdom, wit and foresight of Dr. Francis to arise from such a town, and one would only expect someone with a keen ability to see "over the horizon" to come from a place where one can see five different states from the top of Lookout Mountain.

I first became familiar with Dr. Francis in 1994. At that time, Lew Rockwell, who was (and still is) with the Ludwig Von Mises Institute in Auburn, Alabama, and the late Murray Rothbard, who was a Professor at the University of Nevada, Las Vegas, co-published a monthly libertarianoriented opinion journal, called the *Rothbard Rockwell Report*, or simply known as *RRR*.

Most months, Rothbard and Rockwell split the column-inches in the magazine, but one month's issue I remember from the Summer of 1994 was unique in that the issue only had two major-length articles, and both were by Rothbard. The first was about recent libertarian-oriented successes in recent Italian elections, and the second was entitled "The Francisian Way."

After having read about Italian politics, my prejudice was to think that something called "The Francisian Way" was about some obscure monk who lived on top of a hill in a monastery in Italy whose writings influenced modern libertarian thought. Instead, the article turned out to be a laudatory one about nationally syndicated columnist Dr. Samuel Francis, and more specifically, about his biting style of witty prose. Now keep in mind that, at the time I was reading this magazine article, I was all of seventeen years old, but still, I had already encountered my share of great wordsmiths of the American political right (some not as "right" as others). The article whetted my appe-

tite, but my searches for columns, essays, books or articles by this Samuel Francis were in vain—remember, this was at about the time when the World Wide Web was just sprouting buds as a major research tool.

So I let these personal curiosities fade to the back of my mind, while I bounced around from one right-wing thing to another, one writer or scrivener to another, one idea to another, all the while, I never found anyone or anything out there that I was totally comfortable with.

Then came the Council of Conservative Citizens. You know how it goes, you open some magazine to just the right page, or you turn the TV on to just the right cable news channel at just the right time. In my case, I had a certain St. Louis radio station on at just the right time. Before you know it, I became a member, I got the *Citizens Informer*, and there was ole Samuel Francis, right out of the back of my mind and onto the printed page.

Then came his 1997 book, *Revolution from the Middle*, which was such a literary tour de force when it comes to doubly "getting it right" and "saying it well" that from that point on, it became my personal crusade to make "Samuel Francis" a household name.

Then came the November 1997

summately obsessive Francisian disciples, like I am, we at least have read enough of Dr. Francis's writings to understand what "all the fuss" was about. But for those of you who haven't, you will want to snatch up the two aforementioned books, plus any and every major-length essay of his you can find. A good place to start for the essays would be *Chronicles* magazine, *www. chroniclesmagazine.org.* Those elements of his personal resumé are the best examples of how his writing style was both witty and intellectual.

But I have to recite one element of his wit that applies somewhat personally to me, and did apply more so to himself. When I told him personally about the 1994 article in *RRR* whence I first heard of him, he had this to say to me: "Well, it didn't do too good for either one of us, after all, during the next summer, he died and I got fired ."

It has been said of Western civilization that it is simply a long footnote to the body of the matter authored by the learned ones of ancient Athens, and that political debate in Western societies is really nothing more than the postmortem disagreements between teacher Plato and student Aristotle. If you think that's too simplistic, you might be right. But one cannot deny the heavy influential hand that wise philosophers have on people, either in the mode of their individual ways of thinking, or in a more macroeconomic sense, whole societies or factions of societies. Dr. Francis himself was fond of attributing the actions of those he did not agree with to "Voices In The Air," that is, such offending actions were due to those doing the offending surrendering of their minds to highbrow but (in reality) hostile philosophers. This alludes to the lesson of the life and work of Dr. Samuel Francis.

He could be said to be our "Philosopher King," and might also be our "Voice In The Air." But the truth of the matter is that he was our Prophet of the Soil. You see, most people these days who have opinions about something have allowed themselves to become mental shills of political pied pipers who play a sweet tune, but who turn out to be philosophical commissars and change-agents of some special interest whose only interest is itself. Such individuals will overtly advocate things which are blatantly against their own selfinterest and well-being, or even against the general welfare of their family, their nation or their race, because the pied pipers have, in a Pavlovian sense, conditioned their minds to think that their self-interest is no better than the metaphysical details of some "ism."

Dr. Francis, however, was different. I have concluded that, if he had the chance to write a requiem to his life's work, it would read something like this:

"Remember, ideas should not shape people. People should shape ideas, and furthermore, ideas are no more salient than the people behind them. Without certain people, certain ideas are just meaningless ink on paper. Individuals and groups thereof should not be ashamed to follow their own self-interest, and our ideas and philosophies about politics, government and society should be an intellectual codification of our own well-being, instead of the other way around."

CofCC National Conference in Winston-Salem, N.C., the first one I attended, where I finally beheld Him In The Flesh. I wasn't prepared to find out how much flesh, but nobody could bash anyone about that kind of thing, even though he always took his problems in that stead in good humor.

Then I eventually came into his other great book, 1993's *Beautiful Losers*, both it and my copy of *Revolution from the Middle* are thankfully autographed and personalized by the author.

Most of us who regularly read the *Citizens Informer*, if we're not con-

The Federal Invasion of Arkansas In the light of the Constitution

S INCE the Federal government is a parchment created by a written instrument, which we know as the Constitution, all officers of that government, including the President, must look to that parchment for every power that they exercise, whether in Washington or in Little Rock. That is true, not only of the President, but of the Congress and of the Federal courts.

So, we must search the Constitution to see if we can find authority for the actions of President Eisenhower in sending Federal troops to Little Rock and in federalizing Arkansas troops. There are only two provisions of the Constitution relating to such a situation.

One, relating to the use of federalized State troops, appears in Article I and the other, relating to the use of Federal troops, appears in Article IV of the Constitution. The latter provides that the United States shall protect each State "against invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic violence."

Obviously, there has been no invasion or threatened invasion of Arkansas, hence the President had no authority to send Federal troops into Arkansas, except upon the application of the Legislature of Arkansas for the purpose of putting down domestic violence. The Legislature of Arkansas did not ask for Federal troops and since there is no reason why it could not be convened, the Governor of Arkansas has no authority to call on the President to send Federal troops. If the Governor of Arkansas had such authority he has not exercised it. Therefore, the President had no authority to send Federal troops into Arkansas under any fair construction of Section 4 of Article IV or of any other provision of the Constitution. The other provision relating to the use of military force by the President, in Section 8 of Article I, empowers the Congress "to provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrection and repel Invasion".

Obviously, there was no insurrection to be suppressed and no invasion to be repelled in Arkansas; therefore, the Congress had no power to authorize the President to call forth, or federalize the State troops or Militia of Arkansas, unless it was "to execute the Laws of the Union."

Those the least familiar with American History know why the framers of the Constitution were careful to restrict the power of the President to use military force against his own people. George III did precisely that in America between 1773 and 1776, goading the American people into rebellion. The troops he used were redcoats from 3000 miles away, supplemented by Hessians who couldn't speak English. The hoof beats of those foreign soldiers, who came upon the invitation of the tools of the King—not upon the invitation of the colonists or their representatives in assembly, were fresh in the memory of those who sat in the Constitutional Convention of 1787. The court decrees that those soldiers sought to enforce were rendered by judges dependent for their tenure and their daily bread upon the smiles of the Crown. Some of their decrees were rendered by judges sent to the colonies from as far away as North Dakota is from Arkansas. An intelligent high school student ought to be able to reason from his history book why it was that the Constitution was

made to say that if it should ever become necessary to use troops to enforce "the laws of the Union," to be enacted by the Congress, those troops should, in all events, be state militia, or home troops taken from among the folks whose customs and sensibilities they would know and respect.

Shortly after the Civil War and during the Reconstruction period the Congress, while led by sadistic men, attempted to authorize the President to federalize State troops under certain conditions. It is not necessary to examine those acts because the authority of the Congress itself is limited by the specific constitutional provision quoted.

The final and crucial question is whether or not the President acted "to execute the Laws of the Union" in accordance with the Constitution. The answer to that question answers all questions as to the existence of an "insurrection." What are the "Laws of the Union"? The phrase "the Laws of the Union" has the identical meaning as the phrase "the Laws of the United States," which is a part of the "Law of the Land" defined in Article VI as "this Constitution, and the Laws of the United States which shall be made in pursuance thereof;" (and treaties). A decision of the Supreme Court of the United States or any other Federal court is excluded by the definition itself. As a matter of fact, Article III of the Constitution provides that

the judicial power of Federal courts may not extend to any case arising under Federal "law," unless that law be "this Constitution, the Laws of the United States, and treaties made, or which shall be made, under their authority," thus repeating the definition of the "Law of the Land."

No Federal or State court of record in America has ever held that a decision of the Supreme Court of the United States or that of any other Federal court is "the law of the land" or "the Law of the Union." Such decision is never anything more than *the law of the case* actually decided by the court and binding only upon the parties to that case and on no others. As was said by Charles Warren, in his *History of the Supreme Court*, page 748, Volume 2:

"However the court may interpret the provisions of the Constitution, it is still the Constitution which is the law and not the decision of the court."



Federal courts must look to the Constitution for their powers and their jurisdiction the same as the President and the Congress. If jurisdiction is not conferred by the Constitution it cannot be conferred by the Supreme Court itself. Only the Congress may make a Federal law under authority granted in the very first line of the Constitution, which vests the

power to make law in the Congress. The First Amendment predicates our most precious Freedom on the proposition that only the Congress may make a Federal law.

It is contended by some that the 14th Amendment is involved and that such Amendment constitutes a "law of the Union" authorizing the use of State troops by the President. If we concede that the 14th Amendment was legally adopted it provides how it is to be implemented and enforced. That was not left to chance, caprice—or to Earl Warren. It says in its last clause that only the Congress has the power to implement or enforce it. If one line of the Amendment is legal, the last line is legal. If that Amendment confers pow-

er on the Congress to legislate with respect to segregated schools (which need not be discussed here), the Congress has passed no law since its adoption relating to segregated schools in Arkansas or in any other State, except to establish segregated schools in the District of Columbia and to sanction them in laws relating to the distribution of surplus commodities in the schools of the States.

"The Law of the Land" and "the law of the Union" is the same today as it was on May 16, 1954, as it was in 1927 when a unanimous Supreme Court bench upheld segregated schools in Gong Lum v. Rice, as was held in Plessy v. Ferguson in 1896, with one judge dissenting, and as it was during all preceding

and intervening years. The Supreme Court rested its integration decision of May 17, 1954, on sociological writings—not on the Constitution. An alien socialist, Gunnar Myrdal, of socialistic Sweden, was substituted by Warren and Frankfurter for Mason, Franklin, Morris, Wilson, Madison and Marshall.

In the hearings and debates on the Civil Rights Bill (of 1957), questions as to the use of troops to enforce court decrees in school integration cases were specifically raised. There was an old Reconstruction statute purporting to authorize the President to use military force "to aid in the execution of the judicial process" still in the U.S. Code. In order to allay the fears of certain members of

the Congress a section was added to the Civil Rights Bill repealing the only statute in the Code which purported to give the President the power to use Federal troops or State troops "to aid in the execution of the judicial process." When the President signed the so-called Civil Rights Act on September 9, 1957, he swept away the last fragment of a "law of the Union" that might serve as an excuse for the use of troops to impose feudal despotism upon the people of Arkansas or elsewhere.

The only law relating to the use of troops by a President, to execute court decrees, remaining in the U.S. Code, provides for a fine of not more than \$10,000.00 and imprisonment of not more than two years for "whoever," including the President, "wilfully uses any part of the Army or Air Force as a posse comitatus or otherwise to execute the laws."

The President is under the law and must obey as much so as the lowliest citizen of the nation. The crime of a President against the law and the Constitution is a "high crime" because he is sworn to enforce the one and support the other.

There is no "law of the Union" on which the President's order may legally rest. Since the President had no "law of the Union" to enforce in Little Rock he had no authority to federalize Arkansas troops.

The second paragraph of the Bill of Rights records a lot of forgotten history. It says: "A well regulated Militia being necessary to the security of a *free* State, the right of the people to keep and bear Arms shall not be infringed."

When the Militia of Arkansas was federalized by President Eisenhower's edict, the State of Arkansas lost constitutional freedom and its people lost security from despotism.

What is said here relates to right—not might.

It relates to Constitutional power-not usurped power. Boss Tweed once said, "the way to have power is to take it." President Eisenhower has torn a page out of that notorious old man's philosophical book; he has not used a page or a paragraph from *any* law book.
