Thank you for submitting the revised 'Tower D" Overbuild Structure documents on December 4, 2014, entitled "2014-12-04-Updated FEM Analyses Summary" and revised drawings on January 22, 2015 for the proposed new development building at 15 Hudson Yards, a.k.a, Related Co. Tower D, located in the LIRR West Side Yards, Block #704, Lot #1, in the Borough of Manhattan.

We have reviewed your submitted documents, which includes construction drawings and structural analyses. For convenience, we compiled a listing of the drawings submitted by Related Co. in Appendix A. Based upon our review of the listed drawings in Appendix A, we have determined that we have "NO OBJECTIONS" to the proposed new building development foundation and caisson work.

In addition to the above, approval is subject to:

- All work being performed in accordance with the listed drawings;
- The building plans meeting the Department of Buildings' approval in all other respects;
- The construction materials being used for the project, the testing of materials, and the inspection of the work meeting the requirements of the Department of Buildings;
- MTACC / NYCT review for any revisions to this proposed construction, or for the use of cranes for construction in this vicinity.

Should there be any changes in the scope of work subsequent to the dated drawings, herein mentioned, and / or any deviation to the structural design loading of the overbuild structure onto the existing MTA No. 7 Line West facilities, a resubmission of the design for review and approval is required by MTACC / NYCT.
