All filed to document that the following special inspection is not required for this project: "STRUCTURAL STABILITY - EXISTING BUILDINGS"

When the NB application was originally filed, there was a design TR1 (scan code: ESHS3531150) that was filed on 9/28/2016 which included Structural Stability. However, prior to NB approval, a superseding design TR1 (scan code: ESHS2409027) was filed on 3/6/17 which excluded structural stability. As such during the course of plan examination; prior to approval of the NB application on 5/9/2017, this inspection was waived by the lead plan examiner (waived on 3/1/2017). In addition, there was never a special inspection agency that identified responsibility for it.
