



Aviation Safety (AVS)

Office Operations through September 30, 2013

Due to sequestration-related budget cuts and furloughs, all FAA Aviation Safety offices and facilities will operate with reduced staffing and, in some cases, periodic closures, from now through 30 September 2013.

If you have business with an FAA Aviation Safety office, facility, or individual, please call in advance of your visit to verify hours of operation or to obtain that entity's designated emergency contact information.

Facilities closed due to office-wide furlough and individual employees scheduled for rotating furlough days will resume normal operations on the next business day. For specific information, please see the details below:

<u>The Flight Standards Service</u> – Most Flight Standards field offices have selected two furlough days in each pay period, with approximately half of the employees off each furlough day. However, some field offices will close on one normal business day each pay period, as indicated below:

Allentown FSDO and Greensboro FSDO will close on the first Monday of each pay period (that is, April 22, May 6, May 20, June 3, June 17, July 1, July 15, July 29, August 12, August 26, September 9).

Charlotte FSDO, Teterboro FSDO, Cincinnati FSDO, Cleveland FSDO, Minneapolis FSDO, Chicago FSDO, Columbia FSDO, Alabama FSDO, South Florida FSDO, Albuquerque FSDO, Baton Rouge FSDO, Jackson FSDO, Lubbock FSDO, San Antonio FSDO, Dallas-Ft Worth CMO, and Dallas-Ft Worth IFO will close on the 1st Friday of each pay period (that is, April 26, May 10, May 24, June 7, June 21, July 5, July 19, August 2, August 16, August 30, and September 13.)

Farmingdale FSDO and 142 CMO will close on the second Friday of each pay period (that is, May 3, May 17, May 31, June 14, June 28, July 12, July 26, August 9, August 23, September 6, and September 20).

The Flight Program Division (AFS-60) will close on the second Monday of each pay period (that is, April 29, May 13, May 28, June 10, June 24, July 8, July 22, August 5, August 19, September 3, September 16).

Ft Worth FSDO, Dallas FSDO and Miami IFO will close on May 3, May 6, May 31, June 3, June 28, July 1, July 26, July 29, August 23, August 26, September 20.

<u>The Aircraft Certification Service</u> will discontinue normal operations for the first Friday of each pay period (that is, April 26, May 10, May 24, June 7, June 21, July 5, July 19, August 2, August 16, August 30, and September 13).

<u>The Office of Aerospace Medicine</u> will continue with normal hours of operation, but offices may have limited staff due to furlough days. The Alaska office will be closed on the first Friday of every pay period (that is, April 26, May 10, May 24, June 7, June 21, July 5, July 19, August 2, August 16, August 30, and September 13).
