A review of the enclosed document by ONI and DIA determined that pursuant to 10 U.S.C. 424 and Executive Order 13526 § 1.4(b), the redacted information is exempt from disclosure in accordance with 5 U.S.C. 552 § (b)(1) and (b)(3). FOIA exemption (b)(1) protects classified information that, if released, could reasonably be expected to result in damage to national security including disclosing information of foreign governments. Exemption (b)(3) incorporates various nondisclosure provisions that are contained in other federal statutes.

You are advised of your right to appeal ONI's partial denial of this information. To exercise this right, forward your appeal to the Department of the Navy, Office of the Staff Judge Advocate, ATTN: FOIA APPEALS, 1322 Patterson Avenue, SE, Suite 3000, Washington Navy Yard, DC 20374-5066. Your appeal must be post marked within 60 calendar days form the date of this letter. We recommend you include a copy of your original request and this letter with your appeal.
