- 3. Repatriation action will be instituted in a short time thru GSI(b). 3 District. Northern Det.
- 4. They are not wanted by the Italian government, not having committed anything against the Italian State.

The Bolzano Sub-Section is in the possession of Subjects activities while in the employ of the Germans.

have in the past aided this detachment in its work, under the existing circumstances it is inadvisable to interfere by requesting their release. The French government has requested that Subjects be repatriated to France to stand trial for treason.


