1. Informants.

a. Recruiting.

(1) Source is presently unemployed and has a mother and other relatives whom she hasn't seen for fifteen years residing in Czechoslovakia (CSR). These two factors became the two main avenues of approach used by [b6] an agent of the Czechoslovakian Intelligence Service (CIS), in recruiting Source. [b6] used an indirect method of approach. Her first step was a visit to Source's apartment during the evening [b1]. She gained a hearing by saying that she was bringing a message from Source's mother in the CSR. She related a very disjointed and dubious story of having met Source's mother by chance while on a trip to the CSR, and intimated that she could be instrumental in arranging a reunion between Source and her mother. As proof of these contentions, [b6] displayed part of one page of a letter Source had recently written to her mother. On the reverse side of the page Source's mother had penciled a note for [b6] to deliver to Source. Without filling in the important details of her sketchy tale, [b6] brought her visit to an abrupt conclusion telling Source to meet her the following day for the complete story.

(2) At a loss to understand this whole incident, Source met [b6] [b1] in an effort to obtain further information. However, [b6] took Source on a day-long excursion to Wiesbaden MA4548, West Germany, during which trip she continually questioned Source concerning every phase of Source's personal history. Posing as an employee of a business firm in Nuernburg PV5079, West Germany, [b6] offered Source the opportunity to become [b6] co-worker and earn extra money. [b6] would reveal nothing regarding the nature of the work except that it was purely business, not concerned with politics, and good-paying. Source became suspicious and asked [b6] point-blank if she were an agent. After recovering from her surprise at this question, [b6] laughed it off by saying that Source herself had the outward appearance of an agent. Finally, the conversation came back to Source's mother and the possibility of a reunion between mother and daughter. [b6] asked if Source would be missed should she make a trip to the CSR or Austria. She stated that perhaps Source could travel with her to Nuernburg and then later to the CSR. Source explained that her relatives, except for her mother, were very hostile toward her because of Source's former marriage to a German soldier. Upon hearing this and other hindrances to Source's return to the CSR, [b6] stated in a desperate manner that she had not expected so many difficulties and that "they" had told her it would be so easy. Then [b6] calmed herself and suggested that she and Source could travel to East Berlin, thence to Austria, and then to Prague where they could call Source's mother and have her come to Prague. [b6] insisted that the sooner they went to the CSR, the better. Each time Source mentioned her lack of the necessary papers for crossing international borders, [b6] became more angry in her insistence that no papers were necessary.

(3) At approximately [b1] [b6] and Source arrived back in Mainz. [b6] mentioned that she had to catch a train back to Nuernburg to have a conference with her boss. She stated that she would return to Mainz [b1] at which time Source should have a final answer as to whether or not she would work with [b6]. At Source's request and just prior to their parting, [b6] identified herself as [b6] asked Source not to tell anyone of their meeting. If anyone should become inquisitive, Source was to say only that [b6] had brought a message from a girlfriend in Hamburg. [b6] pleaded with Source not to think of her as an agent. Finally, Source got on a streetcar and left [b6] standing in front of the Railroad Station in Mainz.

(4) [b1] Source met [b6] as instructed and agreed to work with her. [b6] expressed great relief and stated that she had feared that Source might report her to the police. [b6] did not require Source to sign any statement of obligation. [b6] stated that she trusted Source and would never require her to sign for anything.

b. Training.

(1) As soon as Source had agreed to work for CIS, [b6] admitted that she was a trained agent and would, in-turn, train Source to be an agent. Source received numerous EEI which [b6] said would be regarded as a test mission. [b6] also explained that as another test of Source's loyalty, Source would be required to perform a test mission consisting of taking messages from Mainz to Wuerzburg NA6716, West Germany. At a later date, Source was to be taught how to recognize and receive messages through newscasts over Radio Prague. [b6] advised Source that she should be more disposed to working on the side of her "blood brothers" than for the Americans or Germans. In addition to normal reporting to a handling agent, Source was instructed in the use of two special reporting procedures. The first one consisted of a post card mailed at the beginning of each month to a cover address in the CSR. By the use of certain key words, Source will be able to indicate either that all is going well or that she desires to see her handling agent. The second procedure consisted of a letter, using a predetermined, harmless-appearing text, sent to the same cover address in the CSR. The purpose of such a letter would be to give immediate notification of any movement of rockets or the arrival of "refills" for the Redstone Missiles.

c. Contacting of Informants.

(1) [b1] Source was required to memorize and practice a precise method by which contact would be established between Source and [b6] or [b6] representative. [b6] told Source that she was to use a "Kontrollgang" (control route). This route would provide security before meetings with SUBJECT and [b6] or another agent. Starting at the Mainzerhof Hotel located at the corner of Rhineallee and Kaiserstrasse, proceed in a southerly direction towards the next street corner. At the city library, Source is to stop and pretend to look in the show windows of the library. At this point she is to look behind her and check to be sure that she is not being followed and to look for [b6]. If there is no danger, she is to proceed along the street to the corner and observe once again. Source is then to cross the street and walk back in a northerly direction towards an arch through which she will come onto the Rhinepromenade. Before entering the arch, Source is to observe once again to see if she is being followed. If there is danger, Subject is to wipe her nose with a very white handkerchief and leave the area. If there is no danger, she is to go through the arch and turn right and walk along the river until she comes to a newsstand. At the stand if there is no danger, she is to buy a package of cigarettes and proceed to a bench located a little farther along and sit down. If there is danger, she is to pass by the newsstand and leave the area. After sitting on the bench, Source will be approached by either [b6] or another person. The person will greet Source in the following manner. "Entschuldigen Sie bitte, koennen Sie mir sagen, wo ich das Gutenberger Museum finde?" (Excuse me, could you tell me where I find the Gutenberg Museum)? Source is to answer in the following manner. "Es tut mir leid. Ick kenne das Gutenberger-Museum nicht. Aber ich kenne die Gutenberg Universitaet. Wenn Sie wunuchen, ich begleide sie dort hin." (I am sorry, I don't know the Gutenberger Museum, but I know the Gutenberg university. If you would like, I will take you there). The key words in the greeting are museum and university. If the person does not insist on seeing the museum, the person was not the contact. If the greeting was proper, Source was to accompany the person and at this time she will receive instructions and/or money.

(2) Source is to perform this control route only when the following conditions are met. In front of the Club Lafayette located on Kapellenstrasse in Mainz is a statue. In the vicinity of this statue is a bus schedule enclosed in a frame. Source is to check every Saturday morning, starting on the Saturday following her [b1] trip to Berlin, and look for a small, wavy, penciled line on the right side of the frame. If the sign is there, Source is to perform the control route

explained above starting at [b1] At first, [b6] instructions were for Source to execute the control route on the day following appearance of the sign, but she changed this stating that she didn't want to make Source work on Sunday inasmuch as Source has a boy friend, and so forth. Source was told that this would be their normal means of communication and that it would always remain constant so as not to confuse Source since she is a beginner. [b6] bought Source a gaudy bracelet to be worn whenever Source performs the control route. In case [b6] cannot be present, the person who does appear will recognize Source by the bracelet, which is to be worn on the left wrist and is not to be displayed if [b6] herself appears. [b6] stated that she would, in the near future, provide Source with a large handbag with Source's initials affixed thereto as a further aid to identification.

d. Security Factors. [b6] never revealed her true name to Source. She assigned the cover name [b6] to Source explaining that cover names were provided for their mutual protection. As another precaution, [b6] explained the control route would be changed after being used two or three times.

e. Payments. [b1] Source was [b1]  
[b1] [b6] assured Source that she would receive an  
[b1] on the following day and that in the  
future she would receive plenty of money. [b1] [b6]  
gave Source [b1] Source was instructed to  
save all her receipts and vouchers covering expenses incurred in the  
course of fulfilling missions so that she could be reimbursed. For the  
rest, her payments would be in amounts proportionate to the value of the  
information she reported.

## 2. Communications.

a. Use of Radio. Source was told that in the future she would be taught how to recognize and receive messages through newscasts over Radio Prague.

b. Use of Mails. At the beginning of each month, Source is to mail a post card to a cover address as follows: [b6]  
[b6] The purpose of this post card is to indicate  
by a predetermined text either that things are going well for Source or  
that she wishes to contact her handling agent. A letter is to be sent  
to the same cover address to report, by use of a predetermined code-text,  
any movement of rockets or the arrival of "refills" for rockets. After  
servicing the letter drop shown to her in Wuerzburg, Source is to go to

the Bahnhof and send a post card with an innocent text to the CSR cover address. The post card should have a picture of a building such as the railroad station in Wuersburg. The purpose of this is to provide a familiar landmark for any person who might have to come to Wuersburg in [b6] place. Source received the impression that [b6] uses the same cover address in the CSR as was given Source. [b1]

c. Use of Codes. Source was given two harmless texts to use on her post card report at the beginning of each month. The text must always be written in High German. In case Source is in trouble or wants to meet [b6] the text will be as follows: "Schoene Gruesse von meinem Urlaub. Ich habe [b6] getroffen und Sie hat geheiratet und die kommt mich bald besuchen." (Greetings from my vacation. I met [b6] and she has gotten married and she will come to visit soon.) The key words are "Urlaub" and "besuchen". If the same text is written, but the word "besuchen" is omitted, this will indicate that all is well. Source was also given a code for reporting by letter information concerning rockets. An example message indicating that a new rocket is coming from the states or that the rockets will be moved in two weeks and giving the number of rockets coming or being moved would be as follows:

Lieber [b6]

Viele schoene Gruesse von hier. Es ist alles in Ordnung. Nur eine Neuheit. Rudi wird sich in zwei Wochen eine neue Einrichtung kaufen, aber er muss sich leider 300 DM dazu leihen.

Dear [b6]

Hello from here. Everything is okay. Only one thing new. [b6] (code word for Rocket) will buy new furnishings in two weeks, but unfortunately he has to borrow 300 DM for that.

The phrase "in zwei wochen (in two weeks) and the use of the future tense of this verb means that the rockets are coming in two weeks from the states, and the phrase "300 DM" means that 3 (three) rockets or refills are in the shipment. If the rocket was moved three weeks ago or a new shipment was delivered three weeks ago and the number concerned was 3 (three) rockets the letter would read as follows:

b6 hat sich vor drei Wochen eine neue Einrichtung gekauft, aber der arme Mann hat noch nicht so viel Ersparnisse und der was sich dazu 300 DM leihen.

(Three weeks ago b6 bought new furnishings, but the poor fellow doesn't have that much money saved and he has to borrow 300 DM).

The use of the past tense of the verb "kaufen" in the letter indicated that the movement has already taken place. The rest of the code is identical with the first example.

d. Letter Drops.

(1) Two letter drops, one located in Mainz and the other in Wuersburg, were shown to Source and she was told that part of her job would be to carry messages from one to the other. The Mainz letter drop is located in the Rosengarten (Mainz City Park - Rose Gardens). From the intersection of Weisenauer Strasse, Rhein Strasse, and Auf der Steig, near the Rose Gardens, one walks in a southerly direction along Abtsgasse Strasse. Park benches are situated along this street. From the above mentioned intersection, one proceeds to the third bench. Directly across the street from this bench a pigeon house may be seen. Between the third and fourth stones in the seat of the bench, counting from the extreme right side, is a small hole. This is the letter drop. Source was required to practice reaching into the hole so as to become familiar with the procedure of picking up messages deposited in the hole. Source is to service this drop only when she receives a signal to do so according to the following scheme. In front of the Lafayette Club, located on Kapellenstrasse in Mainz, is a statue. In the vicinity of the statue is a framed bus schedule fastened to a metal pole in the manner usual at all bust stops. Every Saturday morning, starting on the Saturday following her trip to Berlin, Source is to go to this bus schedule and look at the right side of the frame. If a small penciled square is drawn on the frame, Source is to go immediately to the letter drop and pick up the material there. This done, she is to return to the bus schedule and mark an "X" through the square. After this, if the material so instructs, Source will take the train to Wuersburg, check there for a go-ahead signal, described below, and then proceed to the letter drop in Wuersburg and deposit the material.

(2) The Wuersburg letter drop is located on the grounds of Marienburg Castle. It may be found by proceeding along the following route: Go over the "Alte Main Brücke" which crosses the Main River in

Wuerzburg and leads to the approach to Marienburg Castle. After crossing the bridge, walk on the right-hand side of the street going toward the castle. Eventually, one passes a vegetable stand located diagonally across the street from the museum. At this corner, make a slight right turn and proceed toward the castle on a small street which is in a poor state of repair. As one walks on this street, on the right side going toward the castle, one sees a souvenir shop located across the street. At this point, the street curves to the right and then straightens out. A short distance beyond the curve are steps leading up to the castle. Go up the steps to the first landing where a path leads off to the right. Following this path for a beat 30 or 40 yards, one passes an arch which leads to the castle. Not entering the arch, but proceeding about 40 yards further, one comes to a bench built into the wall. In the left corner of the wall behind the bench, as one faces the bench, is located the letter drop at a height of approximately three feet above the ground. The drop consists of a hole between two large stones in the wall. [b6] stated that a small stone will be placed in the hole after material is placed inside. Source was instructed always to have the material to be deposited in the drop wrapped in tin foil and ready for insertion into the hole. [b6] suggested that Source buy two identical candy bars, using the wrapper of one bar to enclose the message and the other as a decoy in case someone should approach while the drop is being serviced. Source was required to practice the procedure several times for familiarization with the exact location of the drop. When Source has material to deliver from Mainz, her first step, upon arrival in Wuerzburg, is to check for a signal in a phone booth. As one comes out of the main railroad station in Wuerzburg, there is a large fountain directly ahead. To the right of the fountain is a long line of news-stands, vegetable stands, and the like. At the end of the line of stands, one makes a right turn and immediately to the front is a public telephone booth. Inside the booth on the shelf on which lies a telephone directory, a signal will be placed by [b6]. The signal will be placed on the upper right-hand corner of the shelf as one faces the telephone. [b6] will draw a small circle on the shelf before Source arrives in Wuerzburg. Source will check for the circle as soon as she arrives in the city. After delivering the material to the Wuerzburg letter drop, Source is to proceed to the Bahnhof and send a post card with an innocuous text to cover address in CSR. After mailing the card, Source is to return to the telephone booth and mark a cross through the circle. Then she is to return to Mainz. Source was given no instructions to cover the possibility that she might find no circle in the booth.

(3) After revealing these two letter drops [b1] [b1] [b6] told Source that she had planned to take her to another letter drop in Amberg, near Nuernburg, West Germany, but since Source was so exhausted from climbing to the castle, they would go there after Source's trip to Berlin.

e. Communications Security. [b6] remarked to Source that each letter drop would be used only a few times and then new ones would be put into operation. Regarding post cards and letters sent to the CSR cover address, Source was instructed to travel to cities other than Mainz if necessary in order to preclude all such communications being processed by the same mailing point. As an additional security measure, Grete told Source to alter her handwriting in a different way for each card or letter.

3. Transportation. In their several meetings, [b6] and Source made free use of public transportation including trains, buses, trolleys and taxis. Source was given no instructions as to policies or restrictions of any kind with regard to travel. For her trip to Berlin, Source was told to go to the best travel agency in town and make flight reservations.

SUMMARY OF INFORMATION

During the course of an operational meeting with members of the StB in Berlin 33UUU9220, EG, during the period 25 to 28 November 1958, the final recruitment of Source on behalf of the Czechoslovakian Intelligence Service took place. The recruitment process had extended over a period of approximately nine months prior to its completion.

a. Initial Approach: In March 1958, Source received a letter from the CSR, from a person known to Source to have been an informant of the StB during the year 1949. Source had not heard from nor been in contact with this person in any manner since 1949. The tone of the letter indicated that Source was being offered the possibility of a "business deal" but one that could not be settled by correspondence. The writer queried Source concerning the possibility of a personal meeting to discuss the matter. Source replied to the letter under the control of Agency A-VI inviting further correspondence to determine the actual nature of the proffered "business deal." At about the same time, Source received a letter from another person, a Czech re-defectee and suspected double agent, which contained similar remarks. Source also replied to this letter under the control of Agency A-VI. After correspondence with the first writer appeared to be firmly established, the second person discontinued writing to Source. Various proposals were made for possible meeting places, agreement finally being made upon Vienna (nca), Austria, for the period 7 to 14 September 1958, the period of the Vienna Fall Fair. This meeting did not take place because of the restricted number of visas granted by the Austrian government to the Czech Official Travel Agency, which prohibited Source's primary contact, one b6 from traveling to the meeting. Correspondence then continued until October 1958.

b. Personal Approach: During the latter part of October 1958, Source's primary contact, b6 announced a sudden visit to Murnberg 32UPV5178, Germany. Upon arrival, he contacted Source following which there was a general discussion of Source's willingness to cooperate with the Czechoslovakian Intelligence. After Source had indicated his amenability, he signed a vaguely worded agreement which b6 hand-carried to the CSR. Before b6 departure he indicated that another personal meeting would be arranged, probably in Berlin, within a month.

c. Final Recruitment: During the period 25 to 28 November 1958, Source was in contact with two members of the Czechoslovakian Intelligence

Service in Berlin. One of these persons had been identified to him by b6 as being a member of the StB while the other identified himself as representing "an agency of the Ministry of Interior." During the course of the meeting, Source was interrogated concerning his life, background, family and associates, both in the CSR and in Germany. He was debriefed concerning his knowledge of persons of interest to the StB and his knowledge of persons of interest to the StB and his knowledge of the Federal Assembly Camp for Foreigners in Nurnberg, and was assigned EEI concerning individual persons, as well as general EEI. Source was given brief training in secret writing and development methods, instructions in the servicing of dead letter drops, a method for transmission of information by normal international railroad trains, and the use of normal mails for the transmission of information and/or instructions. He was given a payment for which he was required to sign a receipt and was required to sign an obligation to cooperate with "an agency of the Ministry of Interior."

d. Motives Exploited: During the course of all contacts, both personal and mail, no mention was made of any motivation other than financial gain and personal advantage. There was no attempt to appeal to patriotism nor any effort to convince the Source on the basis of political conviction or attitude. The entire matter was handled during personal contacts as a pure "matter of business" with the StB offering payment for services performed.

e. Incentives Offered: Aside from the financial gain in payment for services rendered, Source was offered a safe haven in the CSR should there be any personal danger for him in Germany, and was offered the privilege of repatriating to the CSR, with full citizenship and a good position, however no specific period of service on behalf of the CSR or prerequisite to such repatriation was mentioned.

f. Oaths Signed:

(1) During the course of his first personal contact with representatives of the StB, Source signed a general agreement with the following text: "I declare myself to be in full agreement with the orally discussed accord." This statement was prepared following discussions with b6 believed to be no more than an informant of the StB, was signed only with the true given name of Source, and bore no indication of the date or place where it was prepared.

(2) During the course of an operational meeting in Berlin from 25 to 28 November 1958, Source was required, in conjunction with a

CERTIFICATE

I certify that I have this date received the sum of 340 DM (three hundred and forty DM) from an agency of the Ministry of Interior.

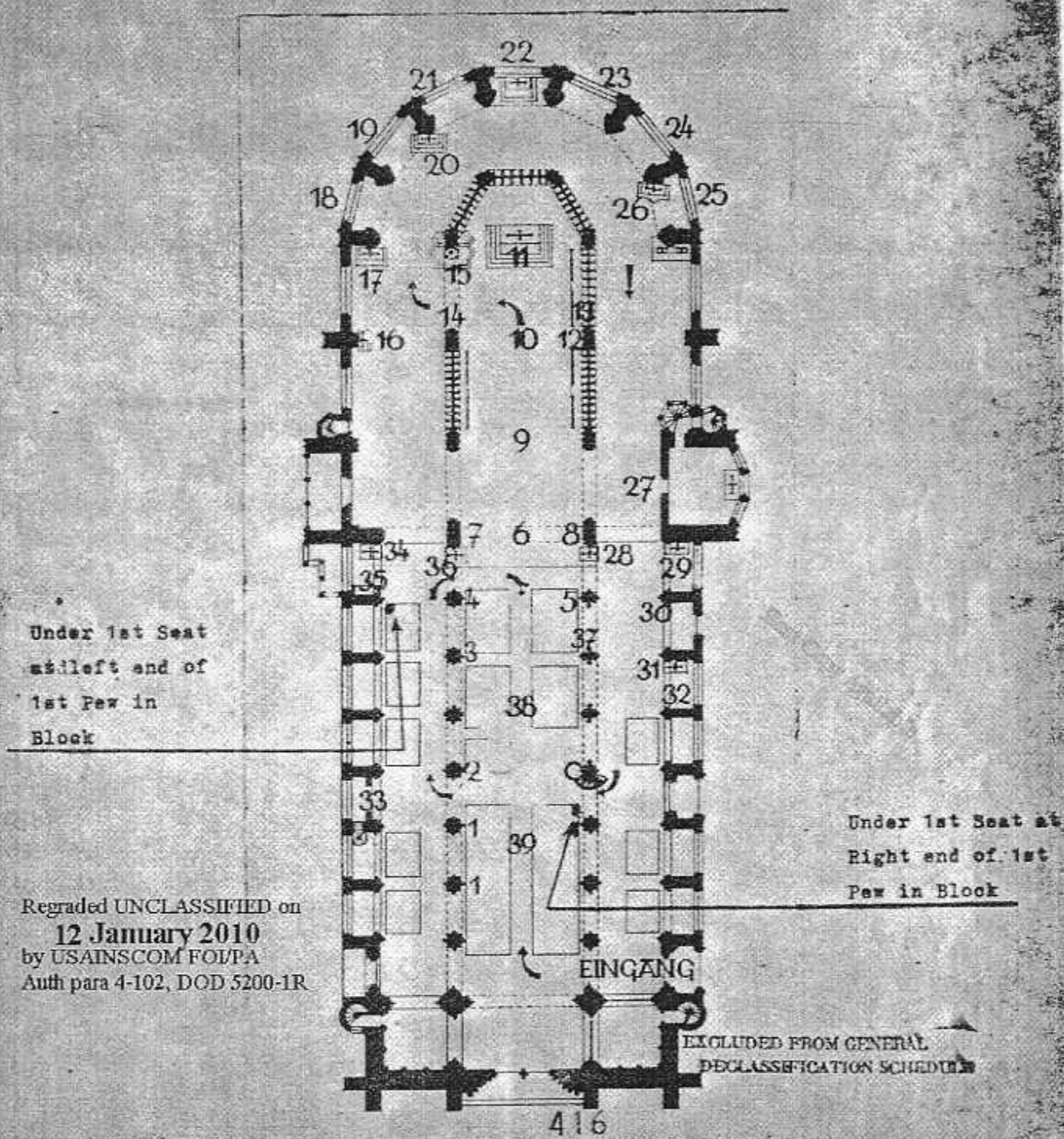
