- Sec. 161.252. Possession, Purchase, Consumption, or Receipt of Cigarettes or Tobacco Products by Minors Prohibited.
- Sec. 481.121. Offense: Possession of Marihuana.
- Sec. 481.122. Offense: Delivery of Controlled Substance or Marihuana to Child.
