The award of the Masters of Arts in Criminal Justice with specialization in Special Operations and Emergency Management Leadership requires the successful completion of a total of 48 quarter units of coursework and 8 units of thesis, with a grade of C or better within each class. All students are required to complete a thesis proposal prior to initiating research and to defend the thesis in a public forum. The degree program is offered using a blend of online instruction and interactive teleconference sessions.

The National Institute for Law and Justice Education is largely comprised of practitioners who are affiliated with a variety of law enforcement and other government agencies, each of whom has made a significant commitment to producing quality educational products for consumption by the profession. Because of the significant number of governmental members involved in the endeavor, the Institute is operated as an NGO that maintains affiliations with regionally accredited colleges and universities.
