

## Canadian Federal Vaccine Mandate Form

Under Transport Canada requirements, passengers must confirm their eligibility to board flight from a specified airport in Canada (Interim Order Respecting Certain Requirements for Civil Aviation Due to COVID-19).

Passengers must have the appropriate documents to prove this eligibility prior to entering the secure area of the airport and/ or boarding a flight.
