Excellency:

The reason for this correspondence is to demonstrate the irresponsible and unreasonable behaviors by the current Canadian government resulting in public discomfort and preventing Canadian communities from functioning reasonably. Also, to underline a "faulty by approach" technique allowing a democratically popular public opinion instead of scientific fact to be the "required factor" to allow for the interference of rights of the highest importance, that being the Laws of Life and Freedom.

While the entire Canadian Nation, with growing international attention and support, is observing a division of opinion, strongly manifested resistance to the government expectations and demands, the legal reasoning for such measures remains of questionable origin.

The Canadian Charter of Rights and Freedoms allows for doctoring of Its content only if "demonstrated in a democratic and free society."

To date, the Government of Canada has not presented or demonstrated to possess any proof or scientific evidence that would indicate that SARS-COV-2 has caused any deaths.

The government has failed to produce one example of a scientific fact that the virus Sars-Cov-2 was isolated from any deceased person and provided it to the public.

Without such being provided, all and any further actions and decisions such as speculations about the behavior and characteristics of Sars-Cov-2

are consequently and factually baseless, without legal stands, and might result in misleading hypotheses.

A belief-based operation is being presented as lawful when the legal requirement for its entitlement has not been met.

Despite this fact:

-the government is expecting obedience for demanding the use of multiple dosed substances in a phase of clinical research and approval.

-Authorities are ignoring data showing that existing products are out-of-date, as confirmed by pharmaceutical companies in their announcements, that they can produce an Omicron booster in just eight weeks.

-the government is not providing any accountability from the manufacturers and the government itself while promoting usage as an act of "being responsible", leaving users faced with a constantly growing list of side effects, including death.

-Enforcing a product with a history and consistency of being "promising at first" followed by recalls and compensations. (ref: US Supreme Court Ruling, Jan 2022)

-legislators are mandating a product of unknown long-term risks.

- the government offers a "privilege" passport, a supposedly helpful tool in limiting an alleged spread of the suspected virus Sars-Cov-2, yet proven to be inaccurate assumptions.

-the government shows consistency in presenting false assumptions such as promoting herd immunity.

-the irresponsible government is attempting to blame the non-users for the inefficiency of experimental and over-advertised products.

- the government is attempting to present an alternative reality as factual while manifesting verbal violence towards any opposition that uses sound right reasoning.

Throughout the ages, the human family has faced many violent government practices, which may have been considered legal at the time.

This eventually created the public defense mechanism referred to as a Constitution or Bill of Rights.

Canada was no exception, legislating the Bill of Rights in 1960, which in its simplicity required the government of a sovereign nation to stand on guard for Its Content.

Entrenched values of law led to Canada's autonomy in 1982.

However, it only took five years for the dishonoring initiative of replacing all together The Bill of Rights (1960) with The Canadian Charter of Rights and Freedom to be legislated under the pretext of enriching human rights in Canada.

Led by "illiteracy in values of Law," legislation cleverly shifted the foundation of a self-governing Nation represented by a responsible

government into an open invitation for a dictatorship-style operation while leaving the Nation legally defenseless.
