Dear Prime Minister Trudeau, the De Facto Government of Canada, Department of National Defense and Mr. Harjit Sajjan, and Minister of Health, Ms. Patty Hajdu, and Chief Medical Officer of Canada, Dr. Teresa Tam,

This letter has been served as notice of your unwarranted harassment activities, or the equivalent thereof, that has been on-going in recent weeks. Therefore, you are required to cease and desist all attacks, including but not limited to: Mandatory Vaccinations including any mandated door-to-door



invasion for the purposes of vaccination coordination, intimidation, and/or coercion in any Canadian Province or Territory of; the Elderly (65+ years of age), Adults (18 - 65 years of age), Youth and Children (newborn to 18 years of age including wards of the Court). This Cease-and-Desist Order includes but is not limited to any and all UN troops anticipated, planned or already deployed in any Canadian provinces or territories for the purposes of this Mandatory Vaccination campaign unilaterally and unlawfully imposed upon any Canadian Citizen or resident.

If you do not cease all related acts, a harassment lawsuit will be commenced against you and Global Intelligence Agency Law Enforcement shall bring you to bear.

Previously conducted actions are unwanted, unwelcome, and have become unbearable. Due to the aforementioned harm you have, are, and will cause, with mandated vaccinations, this cease and desist shall serve as a pre-action letter demanding that you provide us written assurance by July 31, 2021 that you will refrain from further actions that could be deemed as harassment, endangerment, attempted murder and murder under your enforced vaccination mandate(s) now or in the future.

This Cease-and-Desist Order is based on mandatory vaccination dictate measures that are:

- (i) Not Scientifically, nor medically, based nor proven to be effective whatsoever.
- (ii) Pose physical and psychological harm

And that wide sweeping and involuntary vaccination mandate measures violate s.7 (life, liberty, and security of person), s8. (Unlawful search and seizure), and further, be not in accordance, nor justifiable in a free and democratic society.

If you do not comply with this cease-and-desist letter within the aforementioned time-period then a Form 2 – *private information for non-consent*, and in accordance with the Nuremberg code, will be filed against you and further detaining actions in the proper jurisdiction seeking monetary, remedial, and of like-justice damages under natural law as well as the pursuit of all available legal remedies for your harassment will occur.

Further, Form 5.062 – Warrant for Arrest -- will follow if under non-compliance, for contemptuous acts of murder, attempted murder, murder, aggravated assault, trafficking in an unlawful substance for the purpose of genocide, and breach of trust (122 & 336) of the criminal code, et al.

Upon today's notice, you have ten (10) days to respond to the stopping of all forced vaccinations and if there is continued further disobedience, remedial restitutions will commence. If further disobedience still follows, you will be dealt with in dishonor.

AFFIDAVIT STATEMENT OF FACT

This Affidavit is made and effective July 21, 2021

FROM: **The United People's Assemblies et al**, an organized group of de jure assemblies existing under the natural laws.

In consideration of the terms and covenants of this Affidavit Statement of Fact, all matters need to be responded to point for point.

The undersigned authority, on the lands of the People of the Salmon Headsman on this 21th day of July, 2021, of lawful age, deposes and says as fact:

- 1) That mandatory vaccination Agenda and campaigns have been enforced from March 1, 2021
- 2) The vaccines are not scientifically, nor medically, based nor proven to be effective whatsoever.
- 3) The vaccines pose physical and psychological harm.
- 4) The vaccines are extreme, unwarranted and unjustified.
- 5) The vaccines are ineffective and pose a health risk, physical and medical danger
- 6) The vaccines, without informed consent, are unconstitutional and have no force and effect.
- 7) The vaccines infringe on s.2 of the Charter in violating freedom of conscience, religion and thought.
- 8) The vaccines Infringe on s.7 life, liberty and security of the person (and Man) in violating physical and psychological integrity in denying the right to choose, based on informed medical consent.
- 9) The vaccines breach the same parallel rights recognized prior to the Charter, as written constitutional rights through the Preamble to the Constitution Act, 1867.
- 10) The vaccines breach parallel international treaty rights to no medical treatment without informed consent, and right to bodily integrity, which international treaty rights are to be read in, as a



minimal s.7 Charter protection, as enunciated by the Supreme Court of Canada in, **inter alia** the **Hape** decision.

- 11) Mandatory vaccines, under no conditions including coerced compliance to vaccines, are in accordance with the tenants of fundamental justice nor demonstrably justified under s. 1 of the Charter.
- 12) No rationales and motives, and execution of COVID measures, are mandated and passed from the WHO, and are not related to a bona fide, nor an actual pandemic, but rather related to global billionaire, corporate and organizational oligarchs.
- 13) Mandatory vaccines pertaining to the Original People, do alter DNA and therefore are a stealing of original inheritance.
- 14) Upon reminder notice, and as filed in the Hall of Records, all custodial rights have been revoked including by any and all de facto Governments.
- 15) All Peoples of this planet have Sovereign status through the Global Intelligence Agency and therefore fall outside of any jurisdiction that would enact mandatory vaccines.
- 16) Wide sweeping and involuntary vaccination mandate measures violate s.7 (life, liberty, and security of person), s8. (Unlawful search and seizure), and further, are not in accordance, nor are they justified in a free and democratic society.
- 17) Canada is considered a corporation at law and therefore is subject to the Sovereign Man and therefore the First Law of the Land.
- 18) Under the threat of perjury, Health Canada and their Agents are on record testifying vaccines for Covid are safe, but, under testimony, were found to be false and misleading to the public, were in fact unproven and would therefore be subject to the penalty of fourteen (14) year incarceration.

EXHIBIT B

The Spike Protein in the Vaccine injection is a bioweapon defined under U.S. Law.

18 U.S. Code § 175 - Prohibitions with respect to biological weapons

Whoever knowingly develops, produces, stockpiles, transfers, acquires, retains, or possesses any [biological agent](#), [toxin](#), or [delivery system for use as a weapon](#), or knowingly assists a foreign state or any organization to do so, or attempts, threatens, or conspires to do the same, shall be fined under this title or imprisoned for life or any term of years, or both. There is extraterritorial Federal jurisdiction over an offense under this section committed by or against a [national of the United States](#).

(b) Additional Offense.—

Whoever knowingly possesses any [biological agent](#), [toxin](#), or [delivery system](#) of a type or in a quantity that, under the circumstances, is not reasonably justified by a prophylactic, protective, bona fide research, or other peaceful purpose, shall be fined under this title, imprisoned not more than 10 years, or both. In this subsection, the terms “[biological agent](#)” and “[toxin](#)” do not encompass any [biological agent](#) or [toxin](#) that is in its naturally occurring environment, if the [biological agent](#) or [toxin](#) has not been cultivated, collected, or otherwise extracted from its natural source.

(c) Definition.—

For purposes of this section, the term “[for use as a weapon](#)” includes the development, production, transfer, acquisition, retention, or possession of any [biological agent](#), [toxin](#), or [delivery system](#) for other than prophylactic, protective, bona fide research, or other peaceful purposes.
