introduction

the current lack of understanding between citizens who accept the digital covid certificate and those who reject it is the consequence of a financial, industrial and academic logic that was born at the beginning of the 20th century.

at that time, the first petrochemical medicines appeared.

the pharmaceutical industry took off and plant-based medicine was gradually discredited.

in france, the herbalist diploma was abolished in 1941: the way was now clear for the future hegemony of the pharmaceutical industry.

it's the same in switzerland where the profession of herbalist is not officially recognised.

technological medicine has in turn become hegemonic in the west thanks to the pharmaceutical industry and evidence-based medicine.

this medical-scientific discipline should be the rule in academic research, but it cannot explain everything by far and should certainly not be the main criterion in health emergencies such as epidemics.

the hegemony of 'microsoft' was achieved by bill gates by patenting the computer knowledge that his contemporaries shared freely.

at the end of the 1990s, he set up the 'gates' foundation, into which he deposited part of his immense fortune acquired through patents. this is his public fortune. the other part of his fortune, namely his microsoft shares, is managed by a firm called 'cascade investment'. this is his private fortune.

the 'gates' foundation consists of the foundation itself and a trust that manages the assets.

this trust invests solely on the basis of the profitability of the companies, without taking into account their environmental or health impact on the population.

the trust transfers its dividends to the foundation itself, which it transforms into donations so as not to have to pay taxes.

in this way, the capital under management never decreases, but increases over the years.

all donations are conditional (bill gates decides on their allocation).

they allow him to have an ever greater control over the beneficiaries.

the will he had to rule over computing with 'microsoft', bill gates now has it over global health with the 'gates' foundation.

over the past 20 years, he has insinuated a financial hold and influence on many official and academic health authorities around the world (see appendix a).

unfortunately, he doesn't support public health. he only promotes high-tech solutions that only benefit some. instead of helping to strengthen basic health care around the world, he concentrates huge amounts of money on a few diseases and thereby perverts health systems.

he is by far the most influential funder of the w.h.o.

one fifth of the total w.h.o. budget has been spent in recent years on the polio eradication effort...wanted and funded by bill gates.

june 1999

the 'gates' foundation makes its first donation for a malaria vaccine. to date, the foundation has disbursed more than \$ 2 billion towards this goal.

august 2005

in the wake of the sars epidemic, a scientific study is published in the u.s. in the official n.i.h. journal. this study concludes that chloroquine is a powerful inhibitor of the sars coronavirus (sars-cov-1).

january 2010

at the world economic forum, bill and melinda gates pledge to donate \$10 billion over the next 10 years to promote immunisation worldwide. they are accompanied by the ceo of the gavi alliance (an organisation initiated by the 'gates' foundation and based, like the w.e.f., in geneva).

they announce that global immunisation will be the top priority of the gates foundation.

may 2010

in the usa, the 'rockefeller' foundation publishes a report containing fictional scenarios of tomorrow's world. one of them is a pandemic in which totalitarian containment is imposed in china with very good results, authorities around the world strengthen their power over people and in the west biometric population control becomes the norm.

may 2011

at the world health assembly (annual meeting of w.h.o. member states), bill gates, who doesn't represent any state but is the w.h.o.'s main private funder, makes a speech in which he declares that vaccines must reach all human beings, wherever they are on earth.

june 2012

the w.h.o. disapproves of the use of artemisia annua tea to treat malaria patients.

the reasons given are impertinent, even misleading.

the hidden reason is that artemisia annua is very effective, but not patentable, and therefore represents formidable competition for the pharmaceutical industry.

january 2014

the 'gates' foundation significantly increases its funding of the m.i.t. firm 'microchips biotech' to develop a contraceptive implant that can be activated or deactivated by means of a remote control.

march 2015

the 'gates' trust invests more than \$ 50 million in the pharmaceutical firm 'curevac', leader in europe with 'biontech' in messenger rna-based "vaccine" technology.

april 2015

referring to the recent ebola outbreak in west africa, bill gates says pharmaceutical companies should be absolved of responsibility for future epidemics.

july 2015

the anti-malaria vaccine 'mosquirix', developed by the pharmaceutical company 'glaxosmithkline' and cofinanced by the 'gates' foundation, receives a favourable opinion from the european medicines agency. the w.h.o. announces that the vaccine cannot be approved in endemic countries before 2017.

may 2016

inaugural summit in new york of the 'id2020' alliance, a public-private partnership, at which the firms 'accenture', 'avanade' and 'microsoft' present their prototype for identity management based on blockchain and biometric technologies and implemented on the 'azure' cloud platform.

the intention is laudable: it would be to give an identity to the one billion human beings who don't have one today, but the real intention is probably to entrust multinationals with the sovereign competence of the states in the field of identity management.

october 2016

at the european conference on computer vision, chinese researchers present the 'ms- celeb-1m', a large-scale facial recognition technology developed by microsoft.

october 2017

the w.h.o. makes a negative recommendation on artemisinin-based monotherapies. this amounts to a ban on them in malaria-affected countries. this clears the way for the 'mosquirix' vaccine.

november 2017

gavi alliance ceo promotes global digital identification of individuals.

january 2018

following the inaugural summit of the id2020 alliance, the w.e.f. presents the 'known traveller digital identity' solution - a public-private partnership.

one of the partner companies is called 'idemia', which is active in china in the development of e-surveillance of individuals.

april 2019

in the united states, the head of the f.d.a. leaves the government agency and two months later joins the board of directors of 'pfizer'.

december 2019

an article of the m.i.t. reports that the 'gates' foundation is funding researchers to develop technology to store information beneath the surface of the skin during vaccination.

to find out whether the populations would accept such injections, the foundation is also funding opinion surveys in kenya, malawi and bangladesh.

the wuhan municipal health commission reports cases of "viral pneumonia" in the city.

january 2020

in china, chloroquine phosphate is used in the early stages of the epidemic to treat patients.

this remedy is promising and inexpensive, as it is not subject to a patent.

does it represent, in the eyes of the western pharmaceutical industry, a competition that is detrimental to the future profits it intends to make from the coming pandemic?

the fact remains that in france, without giving any explanation, hydroxychloroquine is classified as a poisonous substance by the director general of health, even though it has been used for several decades in rheumatology and infectious diseases (malaria).

on his return from china, the director-general of the w.h.o. congratulated the chinese government on the measures it had taken, in particular the confinement of the entire population.

february 2020

chinese health authorities issue covid-19 guidelines that include chloroquine phosphate for early treatment. this remedy is probably one of the explanations for the few deaths in this gigantic country, while there will be a "hecatomb" of senior citizens wherever the health authorities prevent early treatment.

in france, didier raoult relays a chinese study that recommends chloroquine.

this is the beginning of a controversy in which dishonest scientists financed by the pharmaceutical company 'gilead', notably yazdan yazdanpanah, claim that hydroxychloroquine is worthless and promote the remdesivir sold by the same 'gilead'.

back from china, the deputy director-general of the w.h.o. urges health authorities around the world to copy the chinese containment response.

he also unjustifiably promotes remdesivir.

this product will be recommended in june 2020 by the european medicines agency, and authorised in july 2020 by swissmedic.

this product is not only very ineffective against sars-cov-2, but it is also dangerous, yet in switzerland it is still recommended in ordinance 3 covid-19.

march 2020

the imperial college london, which has so far received about \$ 300 million from the 'gates' foundation, publishes very alarmist reports and recommends general containment of the populations.

responding to questions from his fellow citizens on 'reddit.com', bill gates repeatedly emphasises that population containment is a necessity, and he announces that a digital covid certificate will be introduced next.

many states impose more or less totalitarian confinements on their populations. to date, no scientific study has proven their epidemiological effectiveness.

the w.e.f. publishes documents detailing the 'known traveller digital identity' solution.

in the united states, the department of health and human services absolves the covid vaccine industry of any responsibility from the day before the 'gates' foundation announced that it was committing \$100 million to respond to covid-19.

the w.h.o. is being urged by many states to create an intellectual property sharing pool to combat the epidemic.

it is only in may that it will propose a platform for this: the c-tap.

april 2020

this gives the 'gates' foundation and the pharmaceutical industry time to propose another platform (the act-accelerator) which is based on the non-sharing of intellectual property.

it has a vaccine division called covax.

it is going to be imposed on the whole world and will give power to the pharmaceutical companies.

the 'gates' foundation says that almost all of humanity will have to be vaccinated.

the health authorities recommend that outpatients should only be given palliative care and then, when their condition is too serious, be sent to hospital.

in other words, the health authorities are handing over the medical care of covid patients to hospitals, and this is usually when it is too late.

this recommendation will have terrible consequences, as it will be one of the main causes of hospital overcrowding.

many ambulatory doctors quickly understand that covid patients die not directly from the virus, but from their own body's reaction (very severe hypercoagulation and over-inflammation) and that it is therefore essential to allow ambulatory doctors to treat covid patients.

australian researchers report that in their cell cultures the viral loads of sars- cov-2 are annihilated within 48 hours by a molecule that specialists in parasitic diseases know very well: ivermectin.

this molecule has been used for 40 years to treat many parasitic diseases in humans and animals with great effectiveness, and for the last ten years or so scientists have been gradually discovering its antiviral properties.

moreover, pharmacovigilance databases indicate that this drug is one of the safest in the world. this very high level of safety is probably due, among other things, to the fact that this molecule was not developed by the pharmaceutical industry, but was discovered in a micro-organism that secretes it to defend itself. thus, from april onwards, many doctors and scientists around the world will include ivermectin in the treatments they are developing and in the studies they are conducting.

the w.h.o. does not support a certificate of immunity for people cured of covid-19.

bill gates gives many interviews in which he states that if the public does not get widely vaccinated, life as it was before will not return.

may 2020

the head of the communicable diseases division of the swiss health agency (daniel koch) tells the tv news that from an epidemiological point of view the closure of the schools was not necessary.

the international (w.h.o.) and national health authorities strongly recommend against the use of corticosteroids (anti-inflammatory drugs).

despite this strong negative pressure, a group of doctors in the united states - the flccc alliance - comes up with an early outpatient and inpatient treatment and informs the u.s. senate of the importance of corticosteroids for inpatient treatment of covid.

the w.h.o. hires 'hill+knowlton strategies' to develop a strategy for advertising the global covid-19 guidelines.

this firm has helped the cigarette industry for decades to pretend that cigarettes are not harmful to health. it has helped various regimes guilty of serious human rights violations (indonesia, turkey, uganda, maldives) to improve their image.

july 2020

a european regulation is adopted, which provides for the abolition of biosafety rules for g.m.o. vaccines (abolition of all g.m.o. risk analysis rules, etc.).

in mexico, the state of chiapas is introducing early outpatient treatment - including ivermectin and azithromycin.

this territory has so far had very low mortality rates compared to other mexican territorial states.

august 2020

a study of patients with mild to moderate forms of covid-19 concludes that spontaneous immunity lasts at least 8 months, but probably much longer.

september 2020

the w.h.o. finally recommends the use of corticosteroids in hospital treatment, five months after the first communications from the flccc alliance.

in peru, the 'tayta' operation (distribution of ivermectin in nine departments to all vulnerable people for preventive and curative use), which has been underway for a few weeks, has significantly reduced mortality. mortality will rise sharply again at the end of the year, which corresponds to summer in the southern hemisphere, as the newly elected president will drastically reduce this operation.

october 2020

the w.h.o. enters into an agreement with the wikimedia foundation to supposedly combat misinformation about covid.

however, the hidden agenda is to disqualify anything that can compete with the vaccines and drugs that the pharmaceutical industry is developing.

for example, the "ivermectin" section of the wikipedia article "covid-19 misinformation" is fake news pretending to fight against fake news.

scientists claim in the 'lancet' to doubt the spontaneous immunity of people cured of covid-19. this is not the first time that a prestigious scientific journal has sacrificed science and public health to the financial interests of pharmaceutical companies and their shareholders.

the f.d.a. approves remdesivir in the united states.

the european commission signs a contract with 'gilead sciences'.

there is no scientific justification for this and even the w.h.o. will recommend a month later not to use this product.

this is a clear example of corruption at the highest level in both europe and the united states.

november 2020

the w.h.o. changes the definition of herd immunity: it is no longer the result of people being cured of a disease and those being vaccinated, but becomes a concept applicable to vaccination alone. realising how dishonest this new definition was, the w.h.o. changed it the following month.

in france, doctors are protesting against the health authorities' relegation of early outpatient treatment for covid patients.

in an interview, bill gates says that his foundation has developed very close relationships with governments and pharmaceutical companies, and as such it will play a crucial role in the implementation of the global covid vaccination that is about to begin.

in egypt, the government includes ivermectin in its national covid treatment recommendations.

december 2020

some of the world's most powerful media outlets (facebook, alphabet, microsoft, twitter, associated press, agence france presse, reuters, bbc, the financial times, the washington post, the european broadcasting union, etc.), organised in the 'trusted news initiative', announce to fight the so-called misinformation around covid vaccines.

they organise a worldwide censorship of the arguments against covid vaccines and specifically target their two main competitors: hydroxychloroquine and ivermectin.

for example, 'alphabet' stipulates in its 'youtube' community rules that any content claiming that hydroxychloroquine or ivermectin is effective against sars-cov-2 is fake news, and its search engine 'google' makes articles disqualifying hydroxychloroquine or ivermectin appear in the first pages of search results.

in the united states, the flccc alliance presents to the senate the excellent results obtained with ivermectin both in early outpatient treatment and in prevention.

in fact, since june 2020, many scientists and doctors around the world have reported very high efficacy of ivermectin against sars-cov-2.

as the scientific teams are small and the doctors have only a few hundred patients, these results are statistically insignificant, but nevertheless, for most of them, quite relevant.

however, compared to the thousands, or even tens of thousands of guinea pigs that the pharmaceutical giants have at their disposal, this small number of subjects or patients is still used today (the results do not meet the theoretical criteria of evidence-based medicine) as a pretext for ruling out anything that might compete with the specific vaccines and drugs sold at a high price by the pharmaceutical industry.

the new definition of herd immunity - published by the w.h.o. - mentions spontaneous immunity, but advertises vaccination by claiming that it is less dangerous for the population...

january 2021

in honduras, the government recommends ivermectin to prevent sars-cov-2.

after granting urgent authorisation to 'moderna' for its 'vaccine' the previous month, the head of the f.d.a. leaves the government agency.

five months later, in june 2021, he will join the venture capital firm behind 'moderna'.

if the united states were a true democracy, this 'payback' would be a crime punished severely.

in zimbabwe, despite the negative recommendation of the w.h.o., the government considers authorising the use of ivermectin for early outpatient treatment of covid-19.

'merck' - whose patents on ivermectin have expired - publishes a message praising its so-called selfless generosity to poor countries, pointing out that it has given its molecule to hundreds of millions of people to cure diseases such as river blindness.

february 2021

'merck' publishes another message stating that there is no scientifically valid evidence for the efficacy of ivermectin against sars-cov-2 and that this molecule could be dangerous (a misleading assertion that contradicts its message of the previous month).

moreover, 'merck' doesn't say that it is developing molnupiravir, a specific covid-19 molecule that it plans to sell at a high price.

by way of comparison, a treatment with ivermectin (if recommended by the w.h.o. to control the pandemic) would cost \$ 1, while a treatment with remdesivir costs \$ 2'500.

in brazil, during the covid peak, the mortality rate is much higher in the territorial state of amazonas than in the territorial state of pará: the former has followed the w.h.o. recommendations, while the latter has introduced early outpatient treatment - including azithromycin, chloroquine and hydroxychloroquine.

in japan, the tokyo medical association recommends ivermectin for early outpatient treatment of covid-19.

march 2021

under the misleading claim that there is insufficient scientifically valid evidence, the w.h.o. recommends against the use of ivermectin for sars-cov-2.

the european agency does the same, as does the university hospital in geneva.

their negative recommendations are misleading, if not deceptive.

as far as we know, the w.h.o. recommended the use of ivermectin for scabies on the basis of 6 studies involving about 600 patients.

however, at present (november 2021), 65 relevant studies involving more than 49'000 patients worldwide conclude that ivermectin is highly effective in the prevention of sars-cov-2 and in the early ambulatory treatment of covid-19.

may 2021

the european union proposes a strategy for the development of specific covid-19 treatments, which are therefore patentable, but says nothing about the possibility of re-labelling molecules effective against sarscov-2.

in india, the governments of uttar pradesh, goa, karnataka, uttarakhand, odisha and mumbai adopt a prevention and early outpatient treatment protocol that includes ivermectin, and thus succeed in curbing the current covid peak in their territories.

in mumbai, the indian lawyers' association takes legal action against the chief scientist of the w.h.o. (soumya swaminathan) for disinformation (misleading statements to disqualify ivermectin). a few days later, she will delete content posted on twitter.

the f.d.a. advises not to use serological tests to confirm immunity. the hidden purpose is to disqualify spontaneous immunity in favour of vaccine immunity.

june 2021

robert malone - pioneer of messenger rna-based vaccine technology - is censored by 'youtube' ('alphabet') and banned by 'linkedin' ('microsoft') after reporting on the dangers of experimental "vaccines".

in zimbabwe, health authorities allow the import and use of ivermectin to treat covid-19.

july 2021

there is evidence that a large proportion of those "vaccinated" can get contaminated and contagious.

satoshi omura, the 2015 nobel prize in medicine for co-discovering ivermectin, is censored by 'youtube' for praising the molecule as not only a drug (in treatment) but also, so to speak, as a vaccine (in prevention).

cyber-tech giants 'apple', 'microsoft' and 'alphabet', along with 'amazon', announce record second quarter profits of \$ 65 billion.

these firms all have a vested interest in the prolongation of the pandemic and the digitalisation of life through lockdowns and vaccine certificates.

this partly explains why several of them are involved in the global censorship of hydroxychloroquine and ivermectin.

august 2021

'moderna' and 'pfizer-biontech' get their experimental "vaccines" priced higher in the european union.

several studies prove the superiority of spontaneous immunity over vaccine immunity, but the e.u. covid certificate and the swiss covid certificate continue to favour the vaccinated.

september 2021

the indian council of medical research includes ivermectin in its sars-cov-2/covid- 19 indication in the national list of essential medicines.

the management of the 'riviera-chablais' hospital prohibits a treatment with ivermectin, even though several hundred patients have been treated with very good results (only a few hospitalizations and no deaths).

the swiss health authorities are urging young people to be vaccinated, and universities require students to have a covid certificate in order to be allowed to study.

october 2021

in the united states, the governor of texas prohibits any organisation (municipalities, companies, hospitals, etc.) from imposing mandatory vaccination.

at the same time, the f.d.a. grants 'pfizer-biontech' an emergency approval for their 'vaccine' for children aged 5 and over.

conclusion

everything has been done since the beginning of the pandemic to maximise sales of vaccines and specific drugs (developed during the pandemic and whose exorbitant prices the pharmaceutical industry wants to impose at the expense of global public health).

the more-or-less totalitarian confinements imposed on populations will only serve to terrorise them into fully embracing the global programme of vaccination and digital certification of individuals.

the official and academic health authorities, both international and national, are under the control of very powerful organisations, notably the 'gates' foundation, the pharmaceutical companies and their shareholders which most of them are management firms managing huge amounts of capital (see appendices b and c).

the senseless and scientifically unsound political decision to confine the world's populations would never have been taken without the extremely serious influence of bill gates on the w.h.o. and many national health authorities. vandana shiva once said: "because of the 'gates' foundation, i have watched government after government fall in its sovereignty".

as a result of this containment, bill gates' fortune has grown from \$ 100 billion at the beginning of the pandemic to \$ 138 billion today. this is due, among other things, to the fact that he is one of the main shareholders of 'microsoft' whose market capitalisation has risen during the same period from \$ 1'200 billion to \$ 2'500 billion.

the market capitalisation of 'alphabet' - which is heavily involved in global covid censorship - has risen from \$ 1'000 billion to \$ 2'000 billion.

the activities of the firm that manages bill gates' private fortune, 'cascade investment', are not disclosed, and the managers refuse to be interviewed.
